Property Description

A three-bedroom semi-detached family home situated in a popular residential location close to two junior schools and Burgess Hill Academy, approximately one mile (10 mins walk) from Burgess Hill with its comprehensive range of shops, bars, restaurants, cinema and main line railway station offering regular services to London, Gatwick Airport and the South Coast also a short walk to Lidl supermarket and Wivelsfield railway station. The property comprises in brief: entrance hall, lounge, dining room, kitchen to the ground floor. The first floor offers three bedrooms and bathroom. Outside benefits from ample parking to the front and garage to the side plus an established rear garden. Potential to extend (stpp).

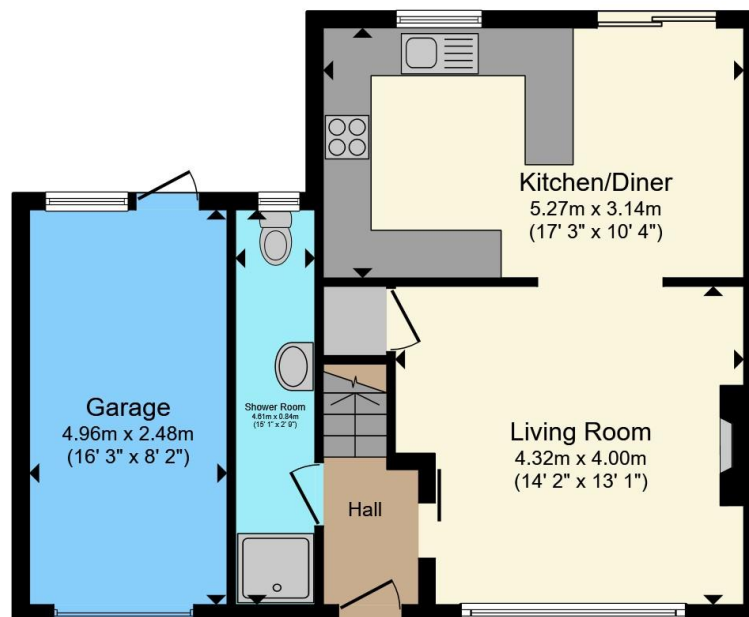

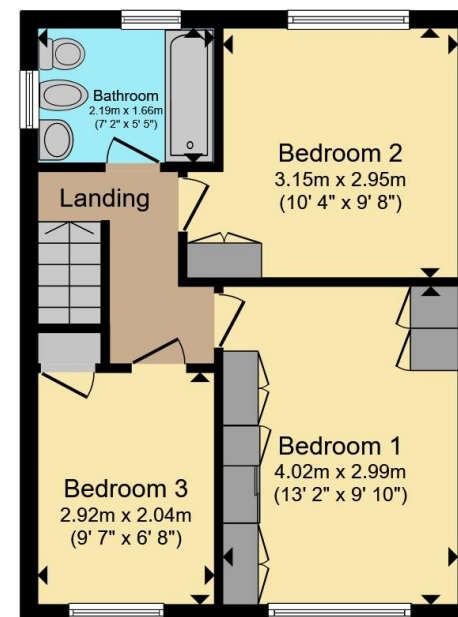








Ground Floor
