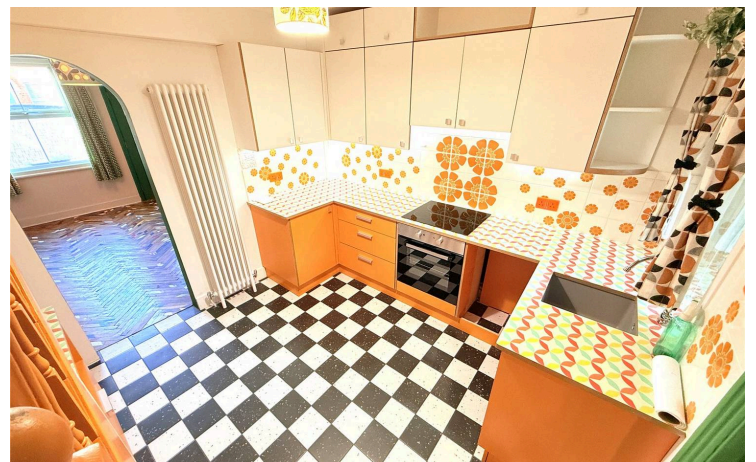

BEDROOM : double glazed window overlooking front, original fireplace, double radiator, stripped flooring, walk in cupboard with hanging rail and shelving.

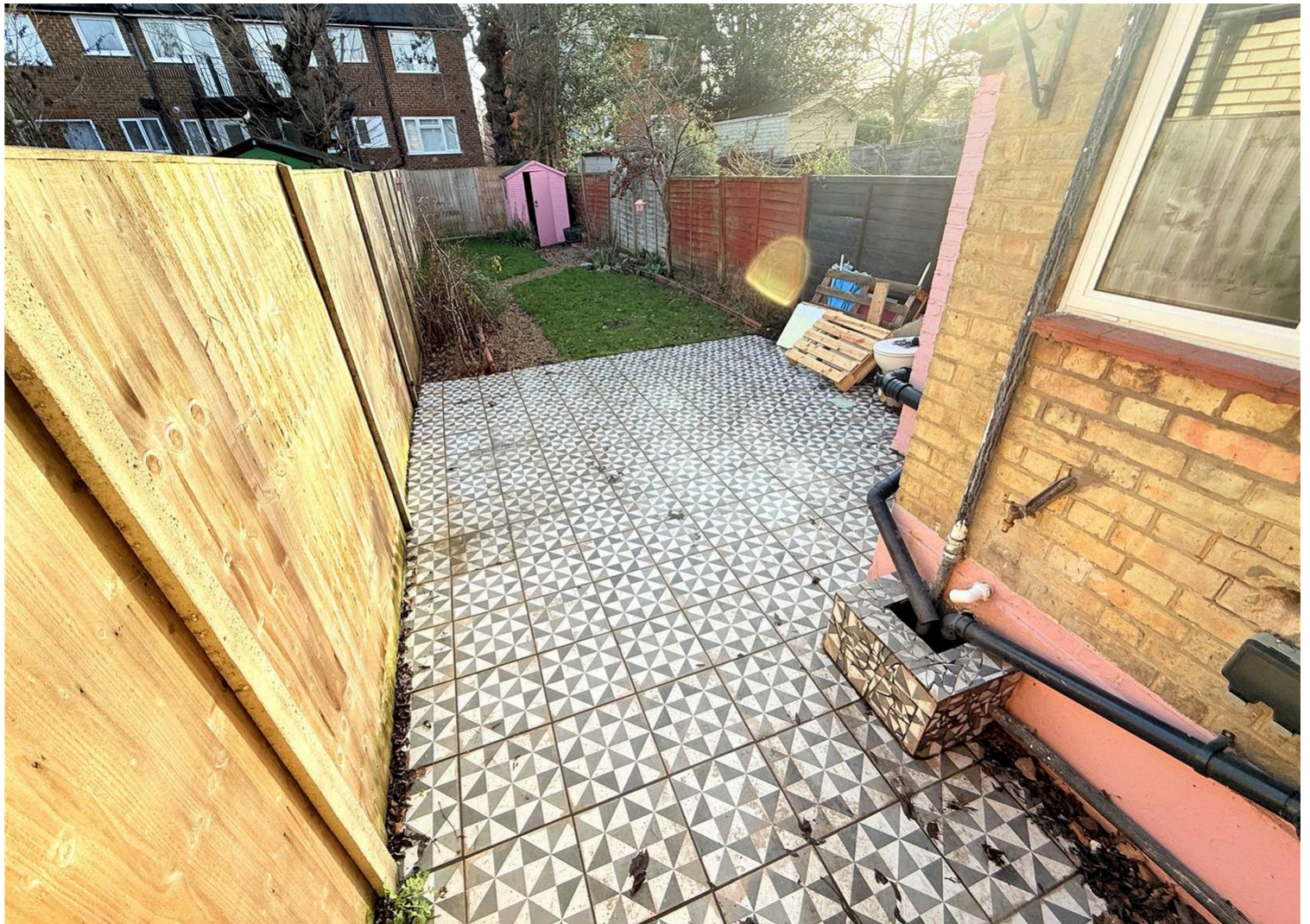

BATHROOM : low level flush WC, wash hand basin, panelled bath, separate shower cubicle, double glazed frosted window, heated towel rail.

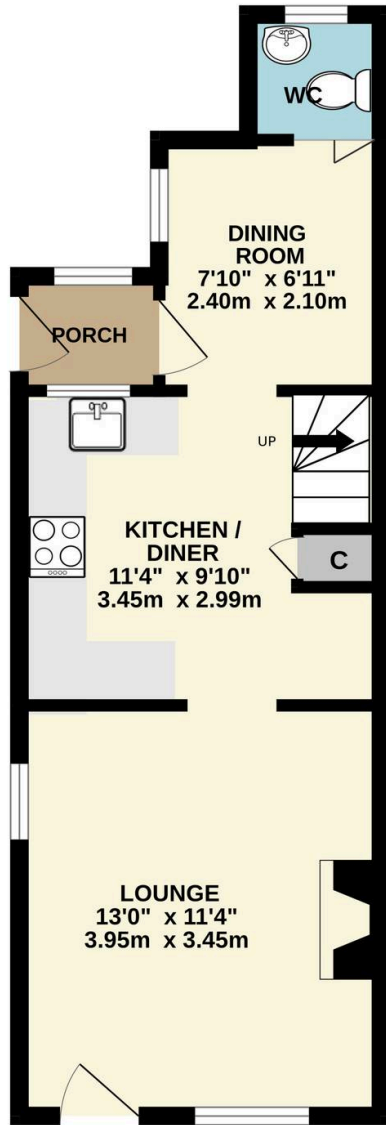
SOUTH EAST FACING REAR GARDEN : initial paved patio area, lawn with mature border, shed.

BARNET COUNCIL TAX BAND D

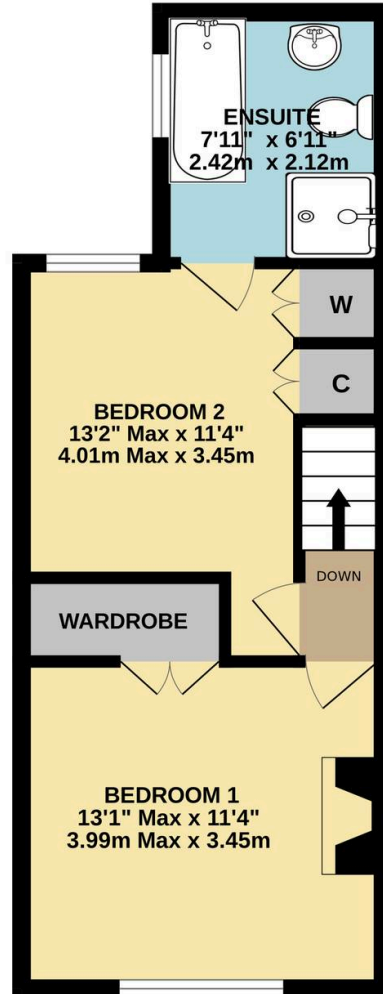




GROUND FLOOR
