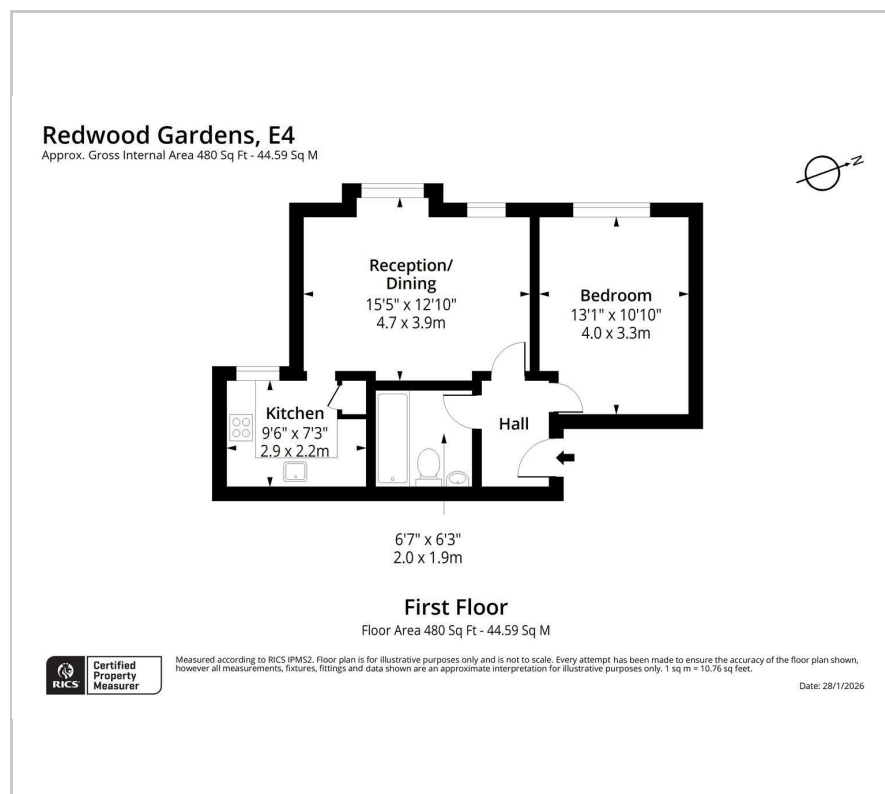

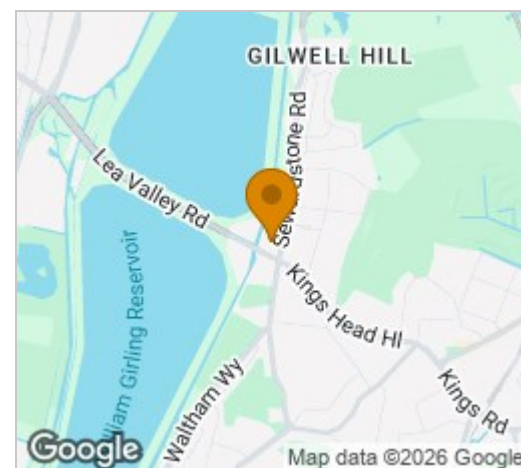

Floor Plan

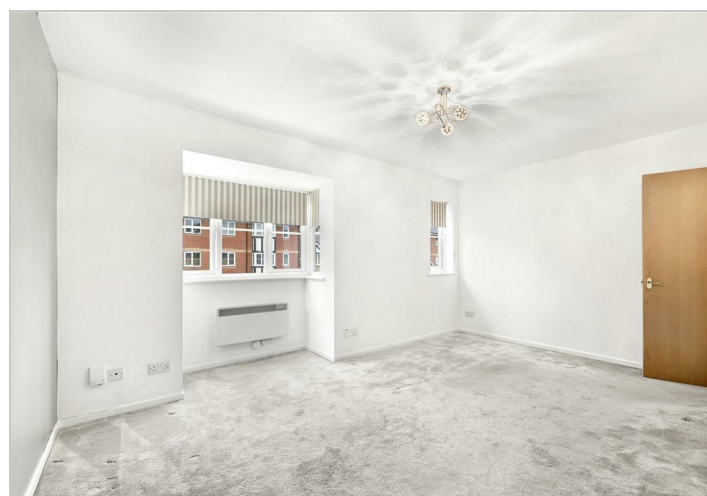


Area Map
