Lawson are delighted to market this spacious mid terrace family home, just a short walk from all amenities, schooling and transport links. The property benefits from accommodation arranged over two floors comprising; a PVCu double glazed front door leading into the sitting room with a window to the front elevation and carpeted stairs leading to the first floor landing and a doorway opening through into the kitchen/diner; fitted with a matching range of base and eye level storage cupboards with post formed and roll top worksurfaces, space for a fridge freezer, plumbing for a washing machine, electric cooker and four burner gas hob, filter canopy, wall mounted Worcester combination boiler, stainless steel sink drain unit with a mixer tap, tiled splash backs and a window overlooking the rear garden, large walk in storage cupboard and doorway to the rear.

The cloakroom has a low level WC, pedestal wash hand basin, tiled flooring and extractor fan. The carpeted stairs ascend to the first floor landing with a pull down loft access and a doorway into bedroom one.

Bedroom one is a spacious double room with two windows to the rear elevation. Bedroom two is a further double with windows to the front and a built in storage cupboard.

The family bathroom is fitted with matching white 3 piece suite comprising, a low level WC, pedestal wash hand basin, panel enclosed bath with a direct feed shower unit above and glass shower screen, tiled splash backs and wooden effect flooring.

Externally, to the front of the property there is a tarmac driveway providing parking for two vehicles. To the rear, the garden is westerly facing, fully fence enclosed with a gravelled patio and lawned area.

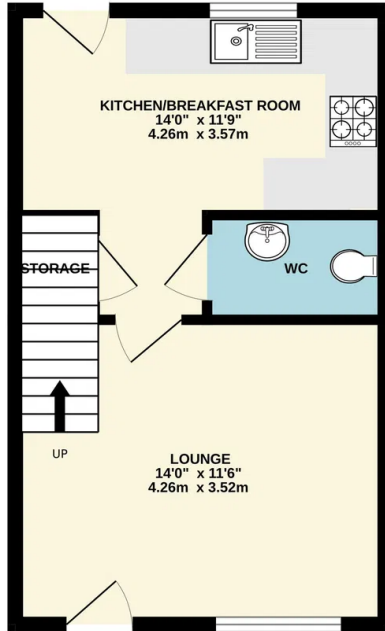

TAMERTON FOLIOT

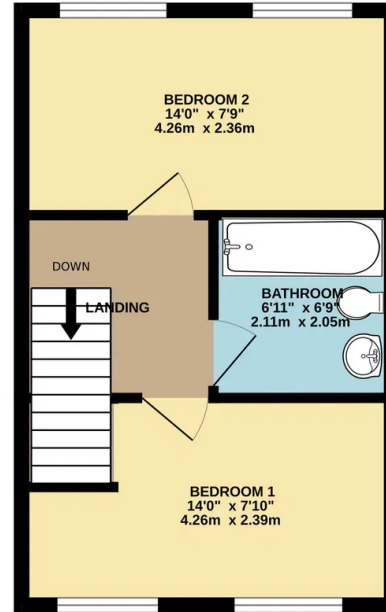

A choice of take away establishments and the popular, highly regarded school, Mary Dean's Primary. Tamerton has a lovely friendly village atmosphere with various clubs and events available to all ages. The village is proud to boast its own quaint annual village carnival/fete, which attracts people from surrounding areas and provides much pleasure for the villagers.
