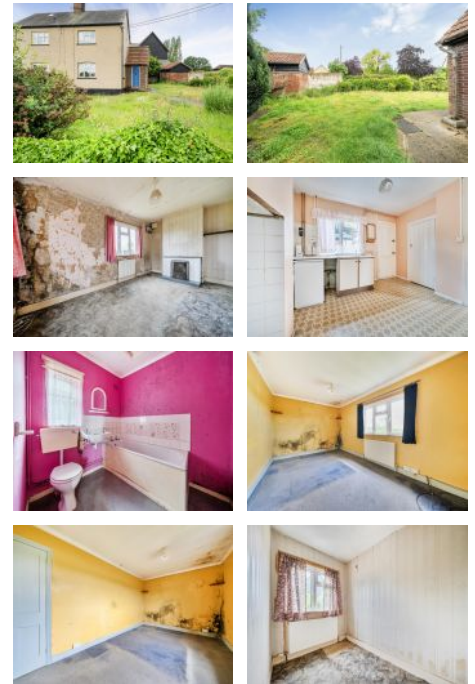

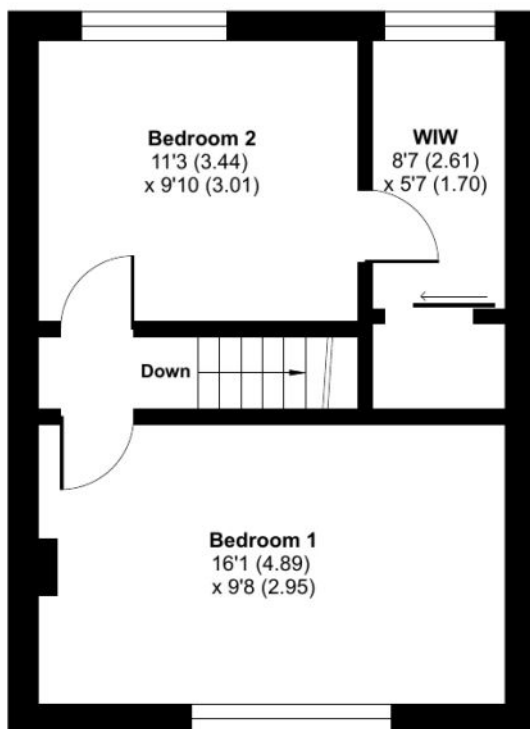

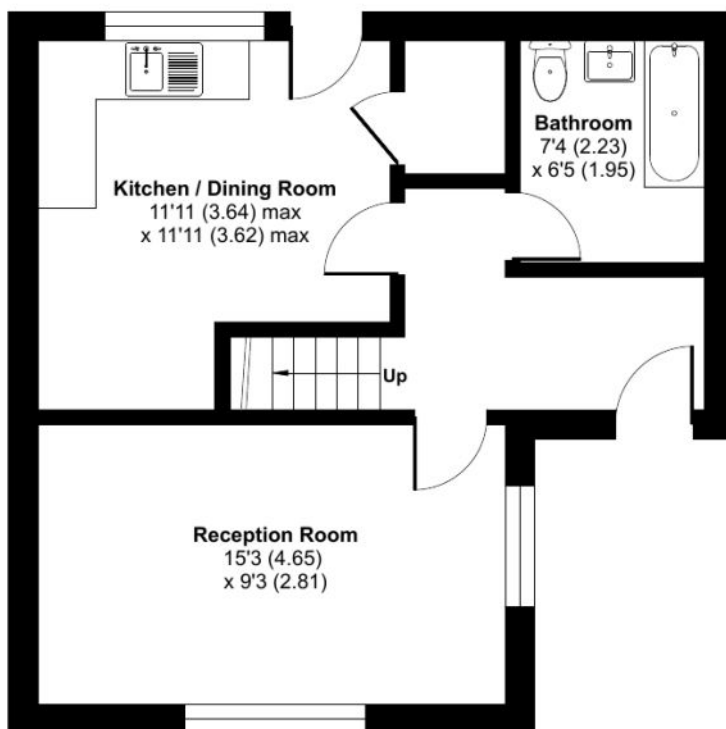
Chelmsford Road, Felsted, Dunmow, CM6
