The property Is entered via an external stone staircase to the rear where a door leads into the entrance vestibule. A door leads into the W.C. which is fitted with a wash hand basin and W.C. set within vanity unit. Opaque window to the rear.

A door from the vestibule leads into the entrance hallway with large storage cupboard.

The lounge offers a window to the side and rear. Feature electric fire. A door leads into the fitted kitchen.

The kitchen is fitted with dark navy base and wall units, coordinating work surfaces. Belfast sink. Halogen hob with extractor above. Electric oven. High level microwave. Window over looks the rear.

Bedroom one offers a feature Bay window to the front. Fitted mirrored wardrobe facilities.

Open plan area offering space to dine, two windows to the front. Open tread staircase to the upper level.

Bedroom two offers Velux windows and storage cupboard.

Bedroom three offers mirrored wardrobe facilities and Velux window to the rear.

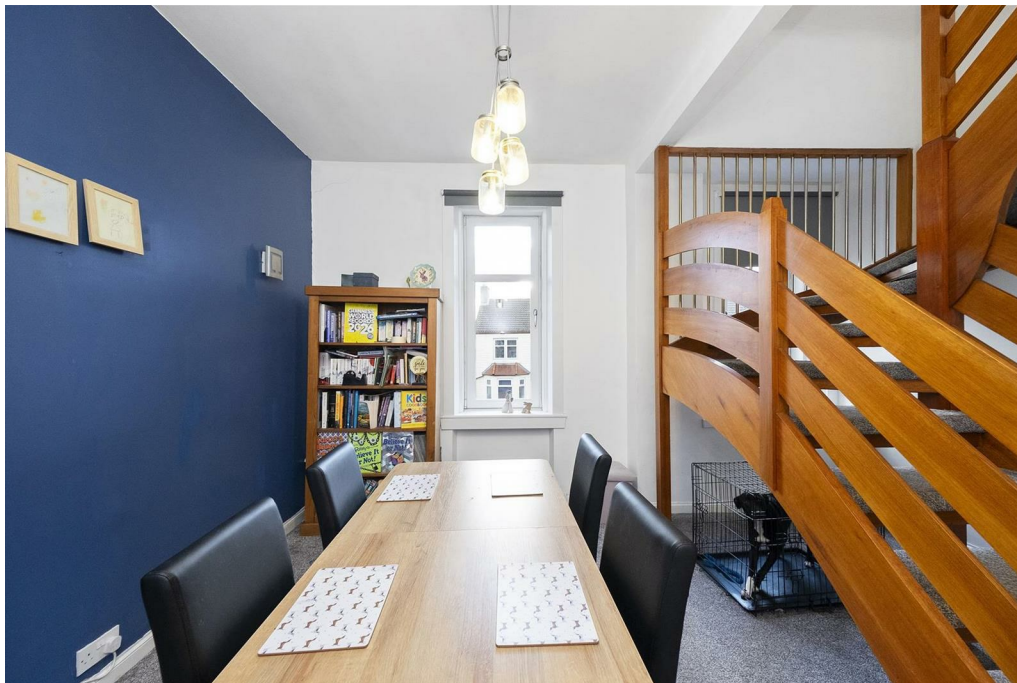
The family bathroom is fitted with a W.C., wash hand basin, bath and separate shower cubicle with mixer shower.

Within the hallway there is access to the attic and a large walk in storage cupboard housing the new central heating boiler.

The property offers gas central heating via a newly installed boiler and all windows are double glazed.

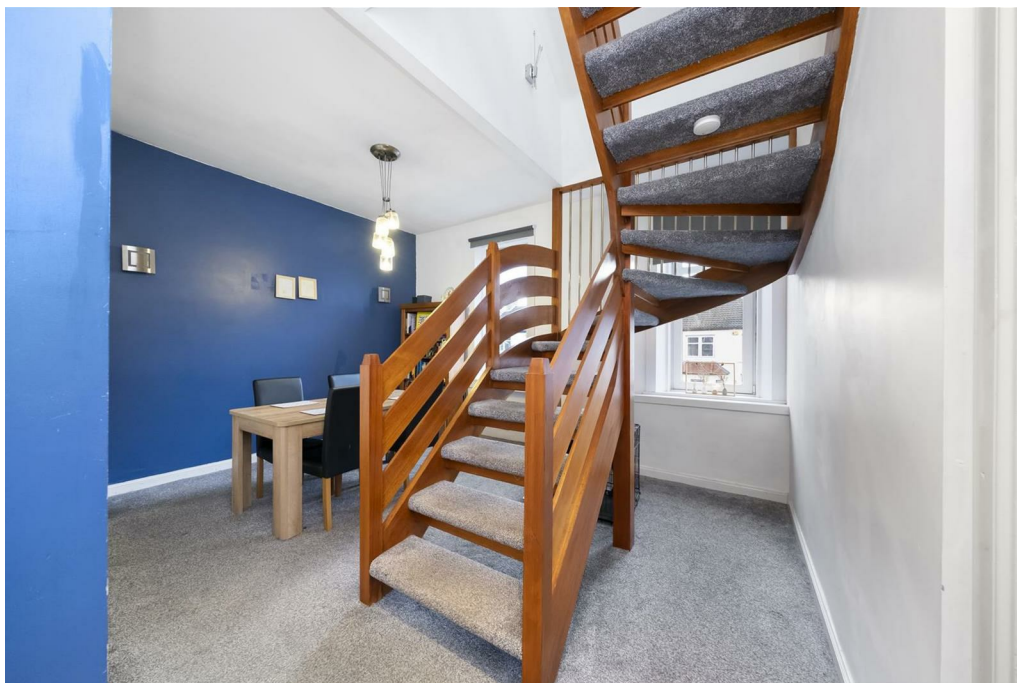
