The property benefits from uPVC double glazing, gas radiator central heating, built in kitchen appliances and further offers a cloakroom, an ensuite shower room to the master bedroom, a south facing rear garden and off road parking for two vehicles. The accommodation briefly comprises entrance hall, cloakroom, lounge, inner hall, kitchen/dining room, master bedroom with ensuite shower room, two further bedrooms, bathroom, garden to rear and off road parking.**

#### Kitchen/Dining Room

15' 5" x 10' 9" narrowing to 8' 5" (4.7m x 3.28m) (This measurement includes area occupied by the kitchen units)

Comprising stainless steel single drainer sink unit with cupboards under, base and eye level units providing work surfaces, built in electric oven and gas hob with extractor hood over, plumbing for washing machine, plumbing for dishwasher, space for fridge/freezer, tiled splash back, cupboard housing gas fired combination boiler serving domestic hot water and central heating, uPVC French doors to rear garden, inset ceiling lights, double radiator.

Window to front aspect, radiator.

#### Bathroom

White suite comprising panelled bath with thermostatic shower over, low flush W.C., pedestal hand wash basin, tiled splash back, towel radiator, extractor vent, obscure glazed window to side aspect.

#### Outside

Front - Off road parking for two vehicles.

Rear - Mainly laid to lawn, patio, shed, outside power point, light and water tap, enclosed by feather board fencing, gated pedestrian access to front.
