Building Plot at Sunny View, Railway Terrace, Pontrilas, Hereford HR2 0BH

This excellent building plot is pleasantly located on the outskirts of the popular village of Pontrilas, between the cathedral city of Hereford (10) miles and the market town of Abergavenny (12 miles).

In nearby Ewyas Harold there are a range of amenities including a shop/post office, fish and chip shop, doctor's surgery, vets, church, 2 public houses, primary school and a sports playing field.

Site

The site is a former garden plot, now mainly lawn.

Planning Permission

Originally, outline planning permission was approved on 08/11/2021 (application reference 212128). This was superseded by an application for reserved matters which (application no 240444) was approved 20/11/2024. Copies of both these consents are available on the Herefordshire Planning portal.

The proposed dwelling will be detached and composed as follows:

Ground Floor

3 double bedrooms, shower room with WC, utility/plant room, balcony

First Floor

Hall, WC, open plan lounge/kitchen/dining room, bedroom with ensuite shower room

Garage with store room/studio over
