Approach

Pathway leads to allow access to the the property via the rear.

Entrance Hall

Spacious hall with doors off to all accommodation, two storage cupboards, central heated radiator.

Tenure (Leasehold).

Referral Fees.

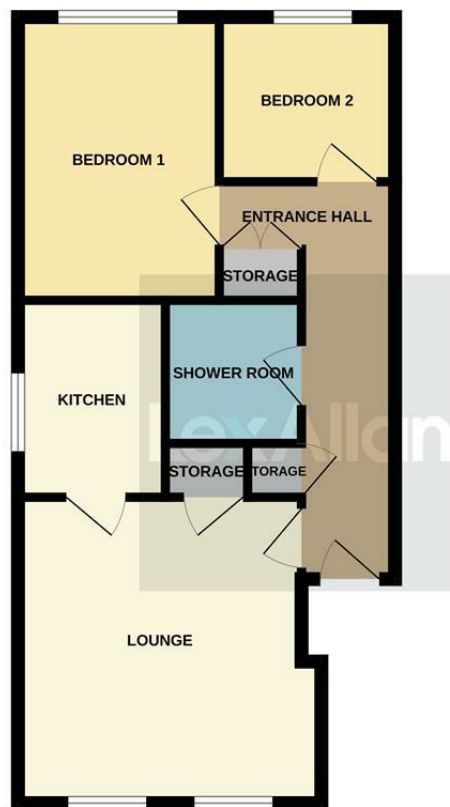
