The accommodation includes a spacious reception hall, cloaks/wc, storage cupboard, spacious living room with log burning stove, stunning open plan kitchen/dining/family room with bi folding doors opening to the rear patio and garden. The kitchen area is fitted with a large island, granite work tops and integrated double oven, microwave, fridge, freezer, dishwasher, wine cooler and induction hob with extractor canopy. From the first floor landing, there is a master bedroom with fitted wardrobes and a luxury en suite shower room, the guest bedroom also has fitted wardrobes and a luxury ensuite shower room. There are two further bedrooms and a luxury family bathroom. Externally there is a gated block paved driveway providing off street parking and access to the integral garage with remote door and pedestrian door to the main reception hall. There is a lovely landscaped rear garden with patio and lawn adjoining open countryside with far reaching views.

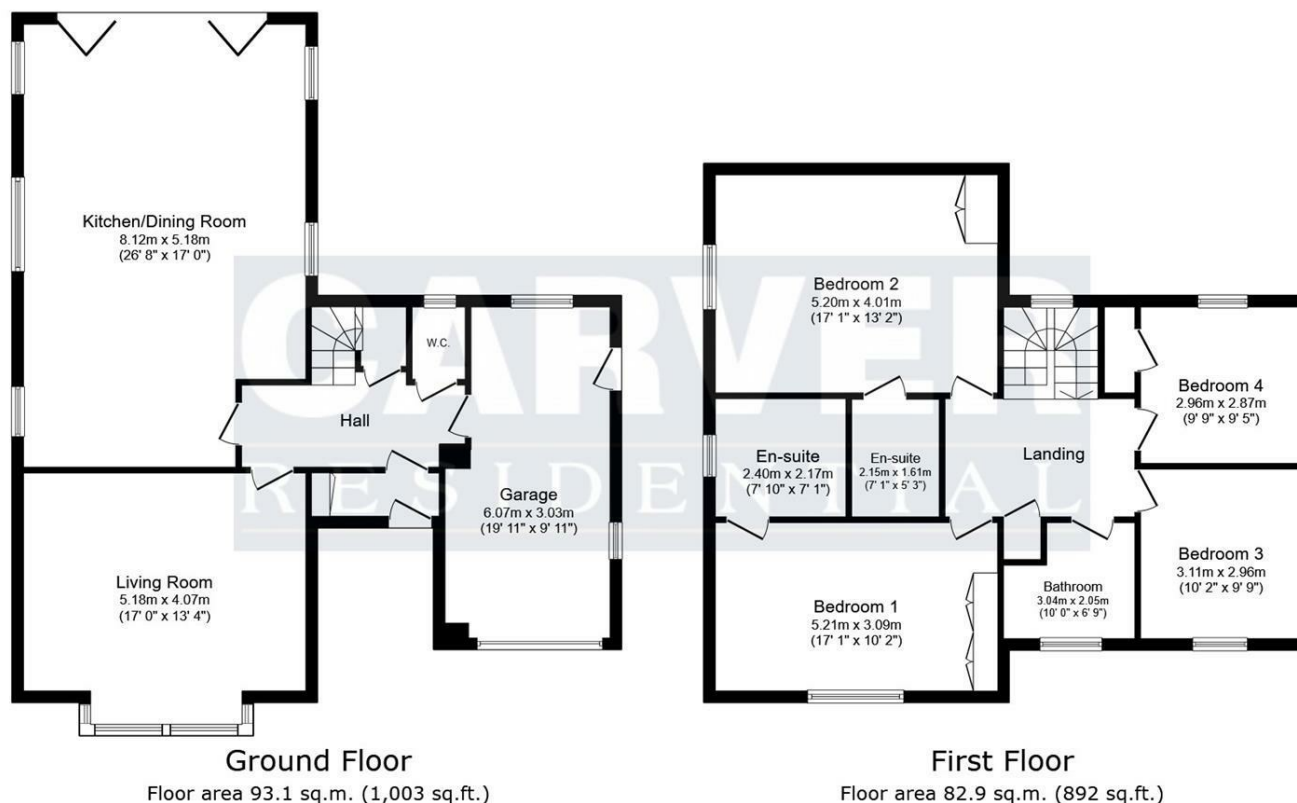
