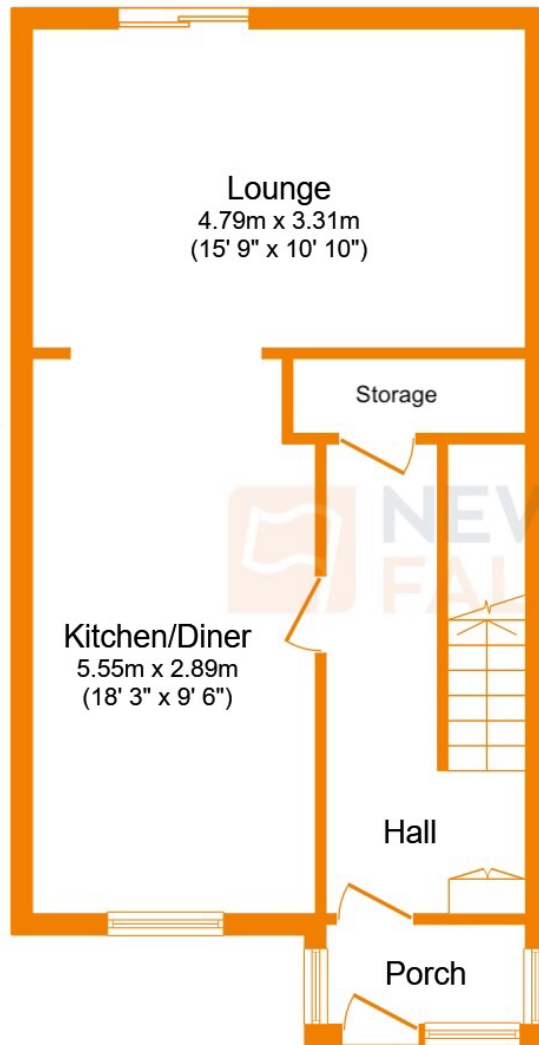

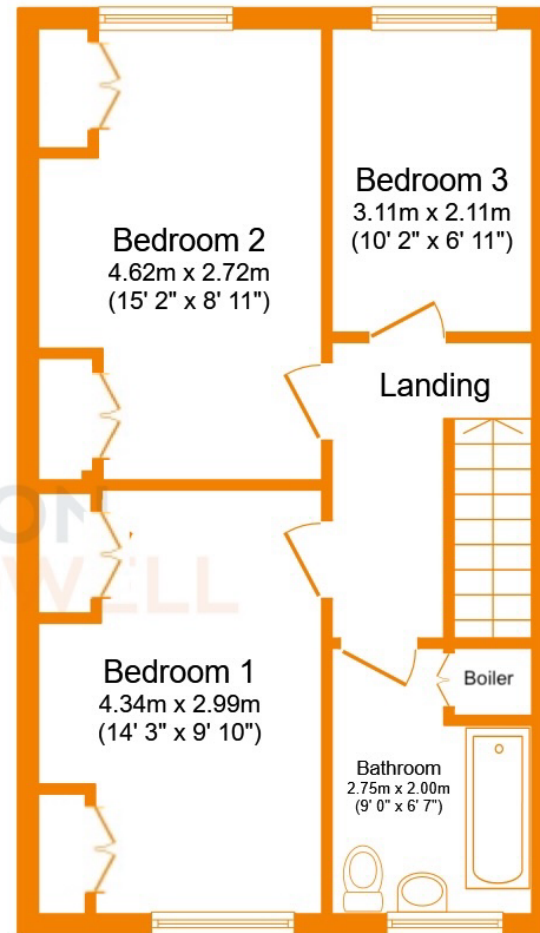








Ground Floor
