### Property Description

Countesthorpe is a large village and civil parish in the Leicestershire district of Blaby. The village boasts its own church which still has the 14th century tower. The village has public houses, two small supermarkets and an award winning Indian restaurant. Countesthorpe provides schooling for all ages with Greenfield Primary and Countesthorpe Academy.

This three bedroom semi-detached property is situated in a sought after cul-de-sac location in Countesthorpe. The property benefits from a recently refitted kitchen and is immaculately presented throughout. Viewing is highly recommended to appreciate the standard this property has to offer.

### Entrance Hall

With a door and window to the front of the property, coving to the ceiling, stairs rising to the first floor and a central heating radiator.

### Lounge/Diner

With a double glazed window to the front of the property, two central heating radiators, coving to the ceiling and double glazed patio doors leading out to the rear garden.

### Kitchen

Fitted with wall and base units, work surfaces housing the sink drainer, integrated electric oven, electric hob, plumbing for a washing machine, space for a fridge freezer, central heating radiator, coving to the ceiling, double glazed window to the rear and door to the side of the property.



## First Floor Landing

With stairs rising from the ground floor, airing cupboard housing the boiler, loft access which is partly boarded (not checked by the agent), double glazed window to the side of the property.

## Bedroom One

With a double glazed window to the front of the property, an array of fitted wardrobes and a central heating radiator.

## Bedroom Two

With a double glazed window to the rear of the property, cupboard with shelving and a central heating radiator.

## Bedroom Three

There is a double glazed window to the front of the property and a central heating radiator.

## Family Bathroom

There is a bath with shower over, wash hand basin, wc, fully tiled walls, LED spot lighting, chrome towel radiator and two double glazed windows to the rear of the property.

## Outside

At the front of the property there is a driveway providing off road parking and a side gate leading to the rear. There is a gravelled area with shrubs.

The rear garden has a patio seating area, steps up to a lawn and flower beds with mature shrubs.


## Garage

With an up and over door, power and lighting.











**Ground Floor**
