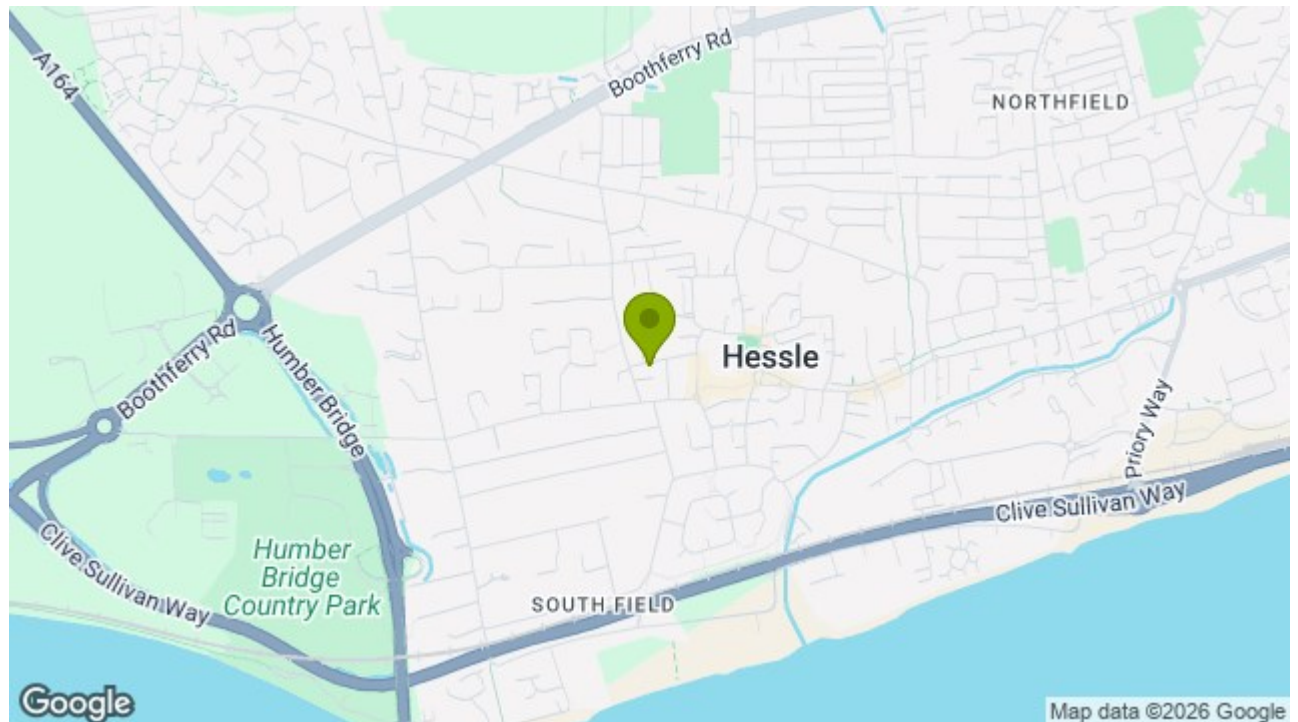

HESSLE

The Town of Hessle is well served for local amenities with first class shopping facilities available within the Town Centre, public transportation & local primary and secondary schools. ENTRANCE HALL

LIVING ROOM

A versatile receptions space currently utilised as a dining space with bay to the rear elevation, access to the storage cupboard.
