Half obscure double-glazed entrance door to the side giving access to the kitchen/breakfast room with a coved flat plastered ceiling, UPVC double-glazed to the front and side elevation, radiator, units at base and eye level with matching drawers and all with chrome handles, square edge work surfaces over incorporating sink and drainer with chrome mixer tap, four ring electric hob with extractor over and separate waist height oven, tiling to splash back areas, breakfast bar, tiling to the floor, opening to the inner hallway

Textured ceiling, doors off to the accommodation, store cupboard, and tiling to the floor.

Lounge

Excellent-sized lounge with coved textured ceiling, large UPVC double-glazed window to the front elevation, radiator, log burner with tiled backing and hearth, wood laminate flooring.

Dining Room

Coved textured ceiling, UPVC double-glazed French

doors to the rear elevation giving access to the garden, stairs to the loft room, tiling to the floor.

Bedroom One

Coved textured, UPVC double-glazed French doors to the rear elevation giving access to the garden with double-glazed windows on either side, and carpet.

Coved textured ceiling, obscure UPVC double-glazed window to side, attractive modern tiling to walls and to the floor, chrome heated towel rail, modern three-piece white suite comprising a 'P' shaped panelled bath with waterfall chrome mixer taps, shower attachment and glass shower screen, sink with chrome mixer taps into a vanity unit, push flush wc.

Flat plastered ceiling, double-glazed Velux window, small eaves store cupboard, door to loft room, and carpet.

Rear Garden

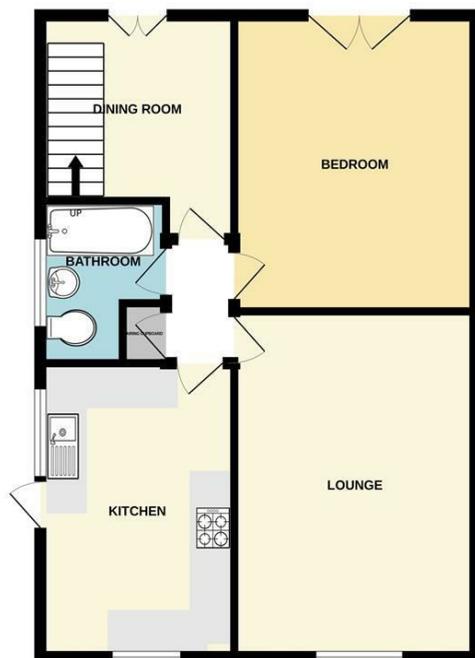

Front Garden

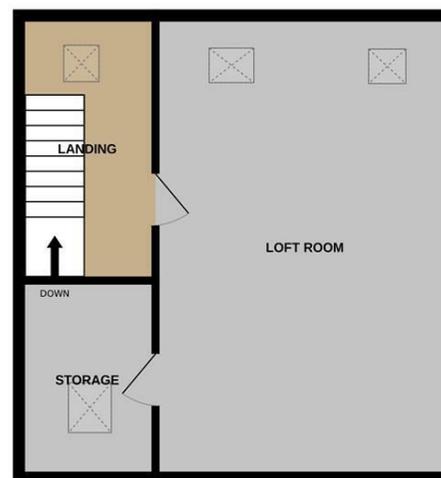
Has a hardstanding area providing off-street parking, a carport, an outside tap, step up to the entrance door
