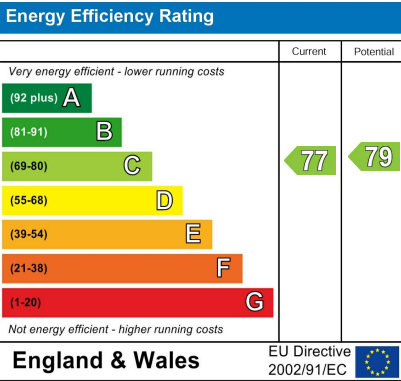

A first floor two bedroom retirement apartment within Meadow Court, a purpose built development comprising 34 apartments set in attractive landscaped gardens managed by Curo. This particular apartment is situated on the first floor of the development and overlooks Brassmill Lane.

The development itself benefits from communal facilities provided for the use and enjoyment of all residents including a residents lounge, kitchen/dining room and further sitting rooms on the upper floors plus communal gardens and residents parking.

An 80% share in the ownership of the apartment is available.

In fuller detail the accommodation comprises (all measurements are approximate):

Communal approach leading to the private door to the apartment.

ENTRANCE HALL

Cupboard with hot water cylinder, night storage heater, two further cupboards.

LIVING ROOM 4.25m x 4.25m (13'11" x 13'11")

Two double glazed window overlooking Brassmill Lane and a further double glazed side aspect window. Night storage heater. Two wall lights

KITCHEN/BREAKFAST ROOM 2.70m x 3.0m (8'10" x 9'10")

Double glazed window. Modern fitted wall and floor units comprising cupboards and drawers. Laminate worktops with inset sink and tiled splashbacks. Built in oven, hob and hood. Space for a washing machine and a fridge freezer. Vinyl flooring, wall fan heater.

BEDROOM 4.0m x 3.0m (13'1" x 9'10")

Night storage heater. Double glazed window.

BEDROOM 3.67m x 2.42m (12'0" x 7'11")

Night storage heater Double glazed window.

SHOWER ROOM 2.16m x 8.87m (7'1" x 29'1")

Modern white suite of WC, wash basin with tiled splashback and tiled shower enclosure with electric shower.

TENURE

The property is leasehold for a term of 125 years from 25th December 1989. The residue of that leasehold interest is available. All of the apartments are sold with an 80% equity with a 20% share being retained by Curo (formally the Somer Community Housing Trust).

The development is restricted to those persons aged

over 55 years. It offers independence with the extra security offered by the support of a part time leasehold officer on site in case of emergency and in their absence an emergency call system which is directed to a 24 hour emergency control facility.

The apartments are sold with no chain. Residents have the security of knowing that the freeholder will undertake the management of the development and be responsible for the maintenance of the grounds, common parts, buildings insurance, exterior repairs and redecoration. The annual service charge for a two bedroom property for the year 2025-2026 is £3636. All tenure and service charge details should be confirmed with your legal advisor prior to exchange of contracts. This particular apartment is situated in the first floor of the development and has an aspect looking out from the side and front of the building.

COUNCIL TAX BAND
