Window to rear, fitted carpet, ceiling light fitting.

BEDROOM 2

11'8" x 8'10" (3.56m x 2.70m)

Window to rear, fitted carpet, ceiling light fitting.

BATHROOM

8'5" x 6'0" (2.59m x 1.85m)

Window to side, sink, WC & bath with electric shower over, vinyl flooring, ceiling light fitting, built-in storage cupboards housing the hot water tank.

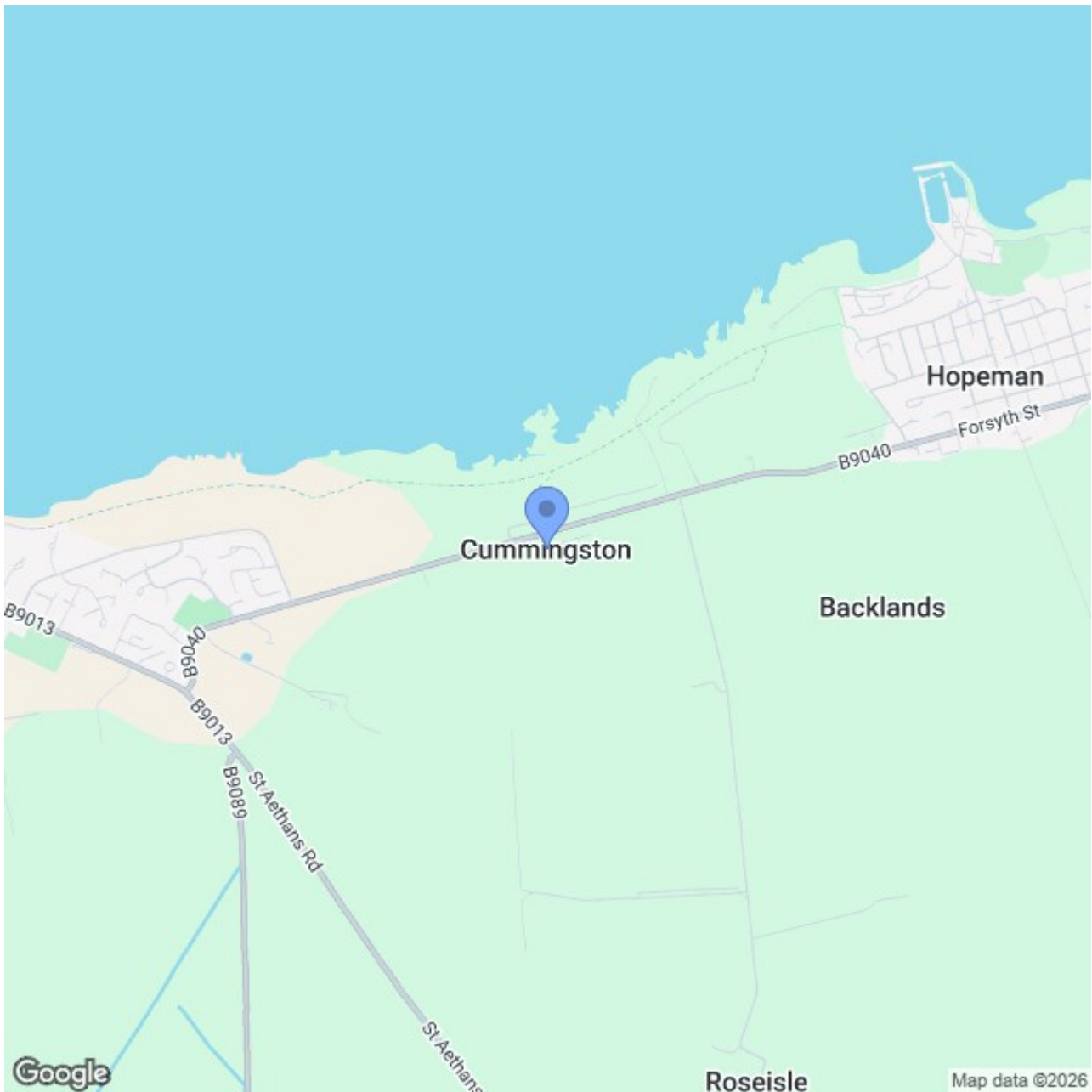
OUTSIDE

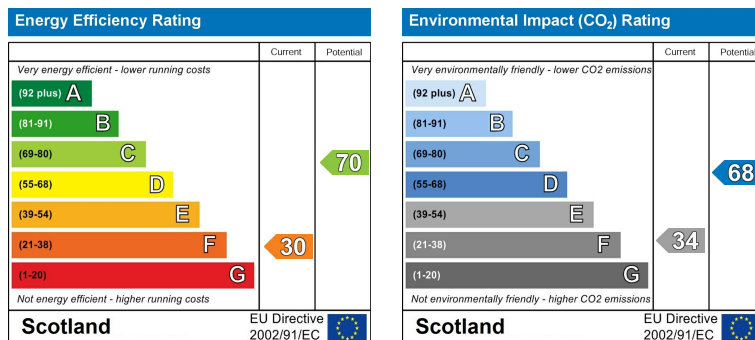
NOTES
