Reservation Fee	£5,000 payable on sales of new properties only. Exchange within 8 weeks from date of deposit. Should you no longer proceed, up to £2,000 is deductible on cancellation.
Exchange Deposit	For new properties, 10% of the purchase price is payable on exchange. Agreed between the parties for resale.
Other Costs	Stamp Duty Land Tax, solicitor fees and removal costs.

Service Charge	£657.19 per month. Changes annually on 1st January.		
Lifestyle Package (Assisted Living Apartments only)	1 Bedroom Apartment £2,746.19 per month (single) £3,636.96 per month (couple)	2 Bedroom Apartment £3,041.67 per month (single) £3,932.44 per month (couple)	Changes annually on 1st April.
Ground Rent	Capped at £250 per annum. Payable on resale properties only.		
Utilities (gas, electric and water)	Included if living in an Assisted Living Apartment or dependent on external provider if in a Independent Living Apartment.		
Emergency Response	Emergency call outs are covered by the Service Charge.		

CARE PACKAGES

Personal Care	Richmond Villages Aston-on-Trent Domiciliary Care Team charges from £31.50 per hour for scheduled personal (domiciliary) care, and from £36.50 per hour for ad hoc personal (domiciliary) care.
Nursing Care	Independent Living and Assisted Living residents can access nursing care through GPs and District Nurses. Nursing care is available on site only in the Richmond Villages Aston-on-Trent Care Home.

CHARGES WHEN LEAVING OR SELLING

Transfer Fee Payment	6% if sold within the first 12 months 8% if sold after 12 months but less than 2 years 10% thereafter or 10% on purchase.
Administration Fees	Solicitors fees for landlord pack £300 including VAT at the standard rate.
Estate Agency Charges	The estate agency service provided by Richmond Villages is free of charge.
Ongoing Charges	In the event of the property becoming vacant, the Lifestyle Package will cease to be payable but the Service Charge and Ground Rent will remain payable until the property is resold.
Redecoration Costs	Under the lease, owners may be required to repair and/or redecorate the property prior to resale.

INSURANCE

Arranged by the Operator	Building, Public Liability and Employer's Liability insurance is covered by the Service Charge.
Arranged by Residents	Residents are strongly advised to take out Household Contents Insurance.

FUNDING OF MAJOR REPAIRS

The Service Charge includes a contribution to the Reserve Fund.

Reserve Fund balance at end of December 2025: £179,783.

Owners may be required to make further contributions in the event of any shortfall in the funds available for major repairs.

CONSTRAINTS ON SELLING

Richmond Villages have first refusal to buy the property back at a price which you want to sell it, less the transfer fee. Purchasers must be over the age of 55.
