Bere Alston is a thriving village with the atmosphere and facilities of a small town. 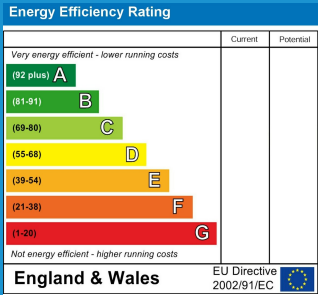
