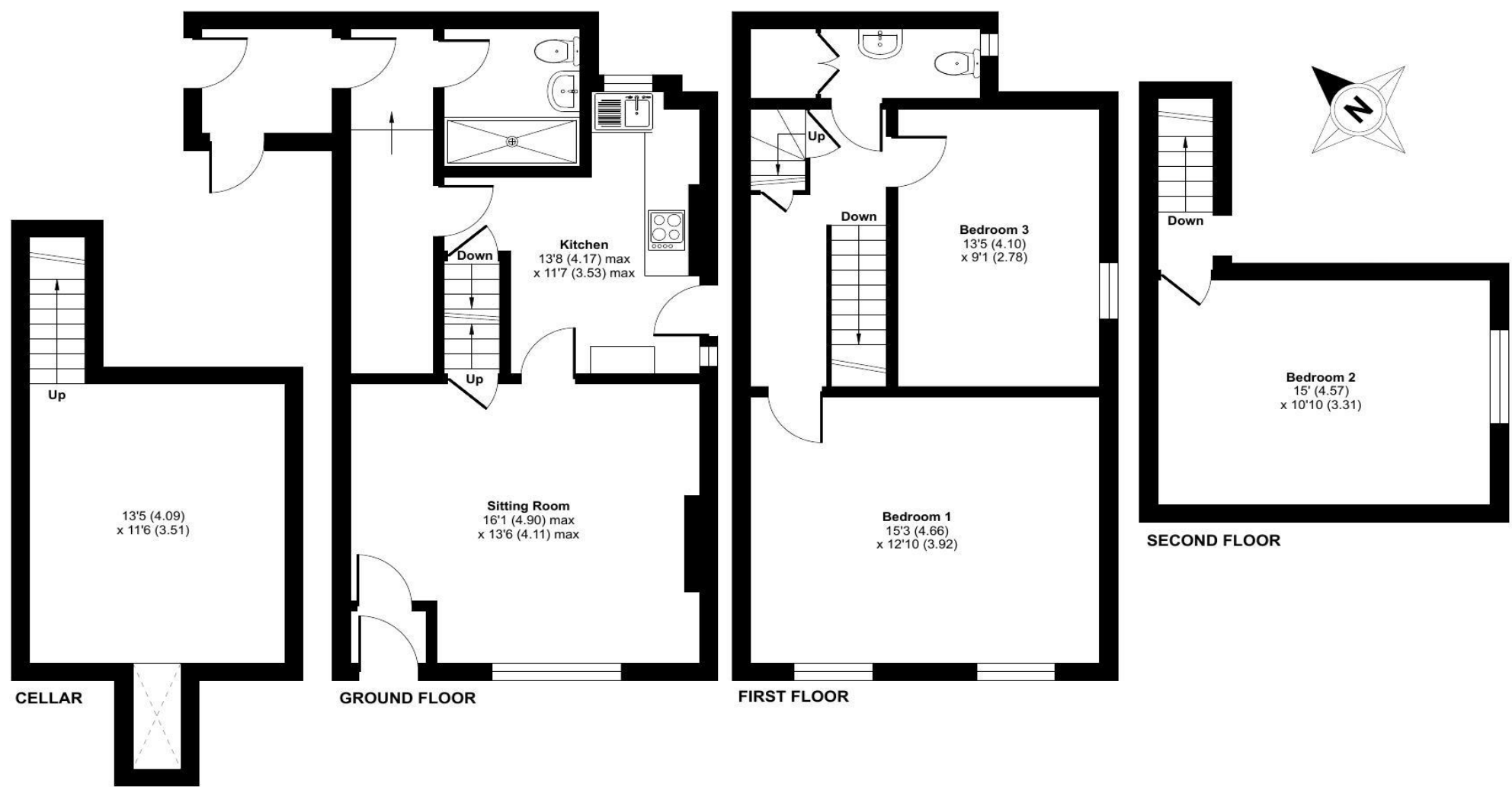

A two bedroom end of terrace character cottage with delightful detached garden, off road parking and useful additional attic room.
