The fully enclosed rear garden is well maintained with an extra seating area leading to the allocated driveway parking.

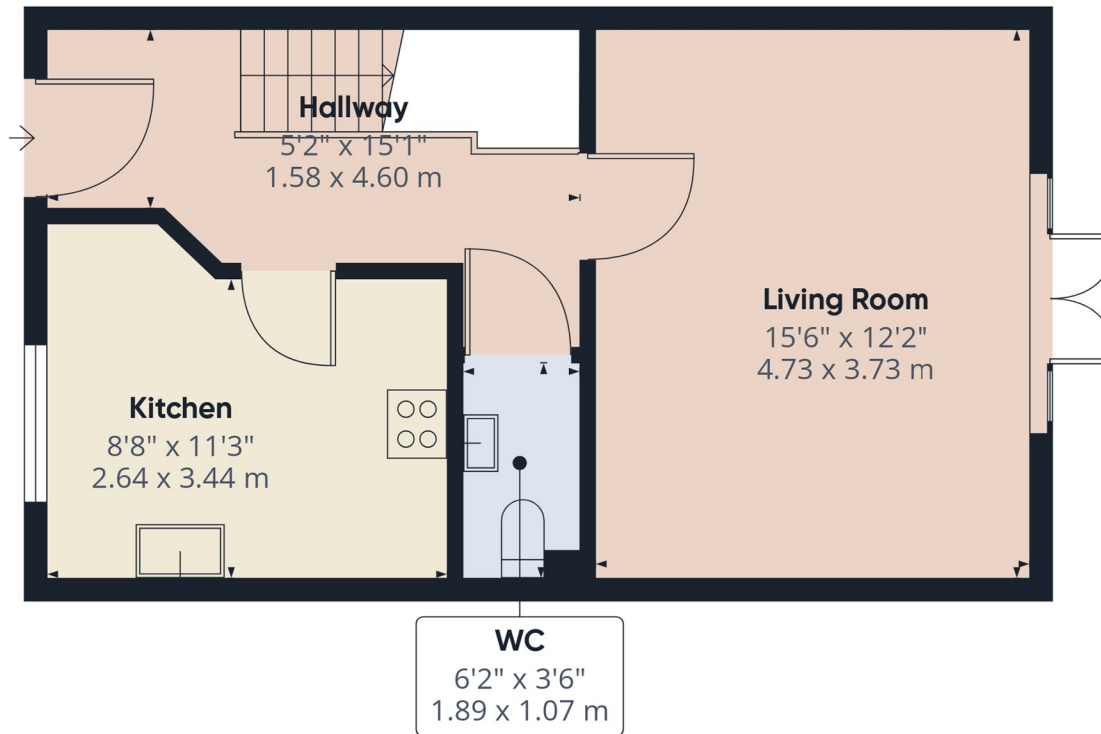
The property is situated within easy reach of Bourne grammar and local shops.

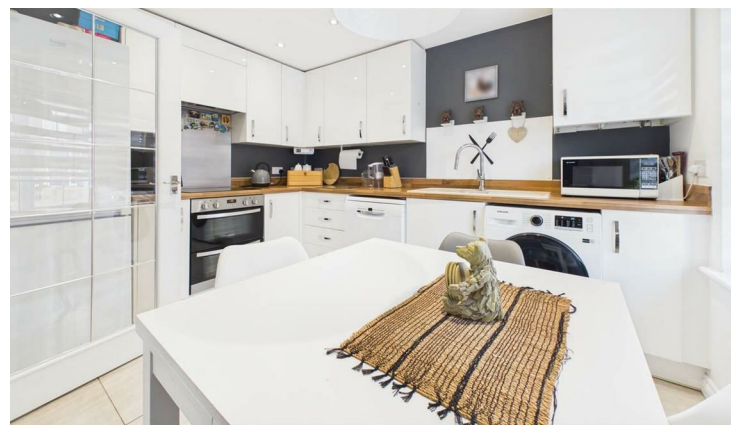
