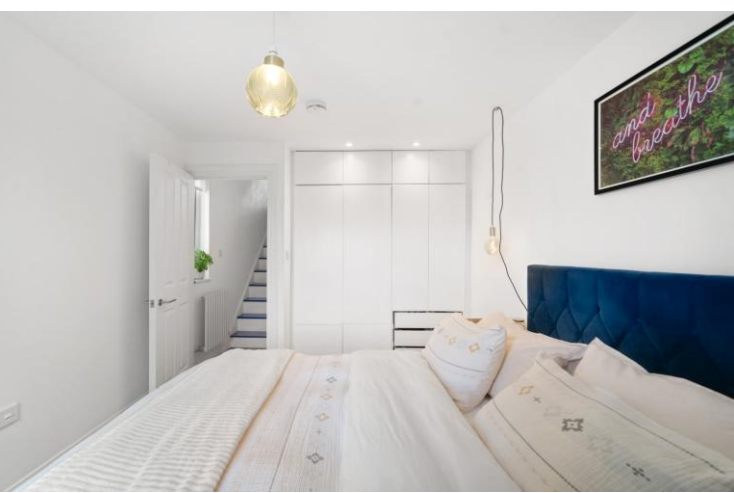

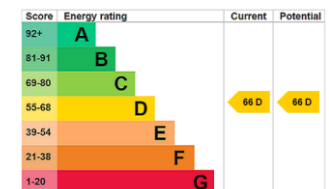
A well-presented upper floor apartment, waking distance to amenities on the Fulham Road, Fulham High Street & Putney Bridge underground station.

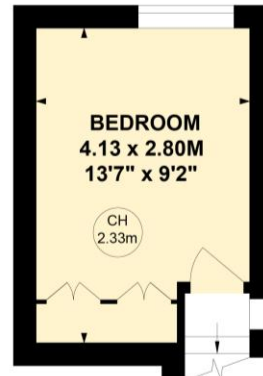
