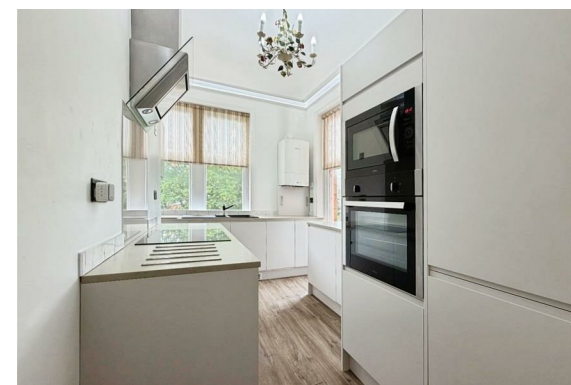

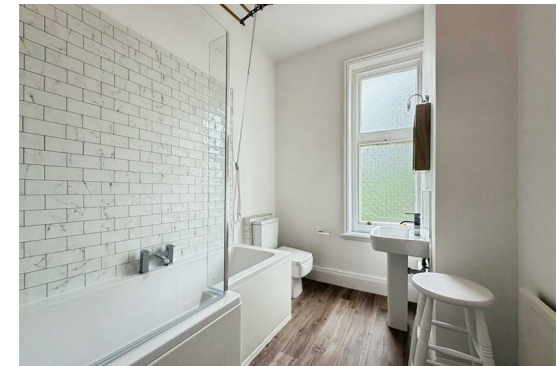

DESCRIPTION

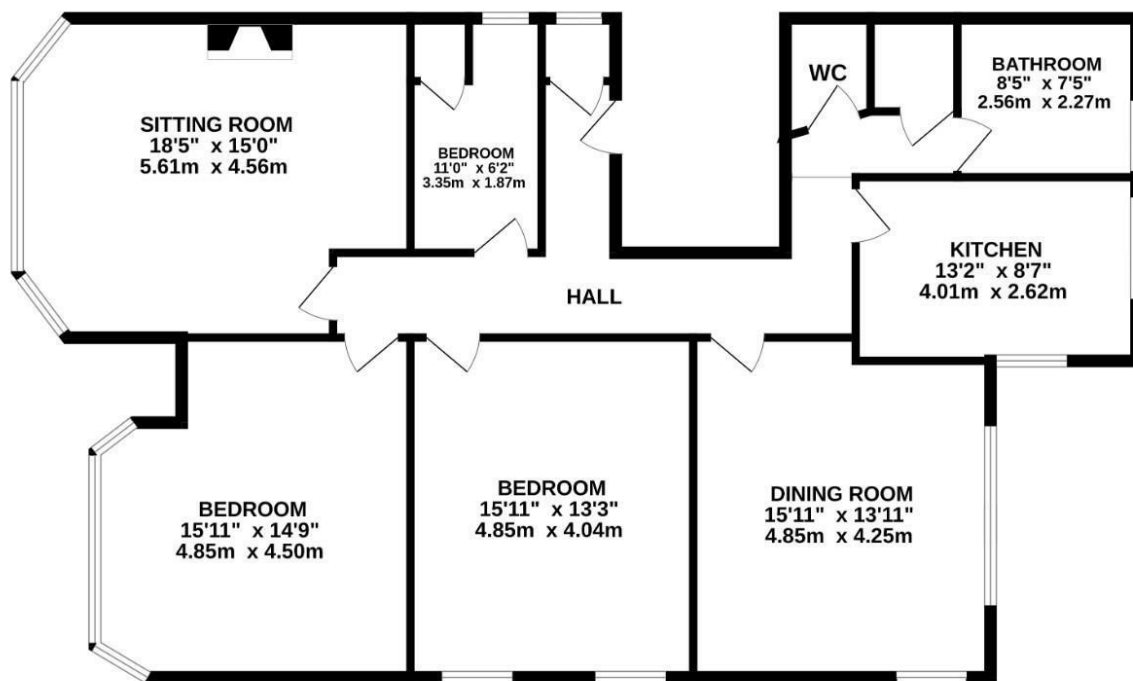
A substantial first floor flat forming part of an imposing and much admired Edwardian building just a moments stroll from the famous Leas Promenade. Noted for its architectural details this distinctive property is set back from the road and is adjacent to the lawned grounds of Terlingham Gardens at the rear.

Offering flexible accommodation to include a generous bay fronted sitting room with period fireplace, to the rear, separate dining room, 3 bedrooms, double aspect fitted kitchen to include oven, microwave oven, fridge, freezer and integrated slimline dishwasher, a family bathroom and a separate cloakroom. There is a useful utility cupboard with plumbing for a washing machine. A gas heating system is installed and many of the rooms have original cornicing to the ceilings. Available to purchase with no onward chain it is believed the property will only be available to cash purchasers owing to some repairs required.

Earls Avenue is a well respected tree lined avenue that ultimately leads to the The Leas promenade which is a mile long stretch that is steeped in history and was formerly owned by Lord Radnor. It offers a beautiful place to sit and relax. The Leas is also famous for the Grade II Listed water balanced funicular railway, presently undergoing restoration.

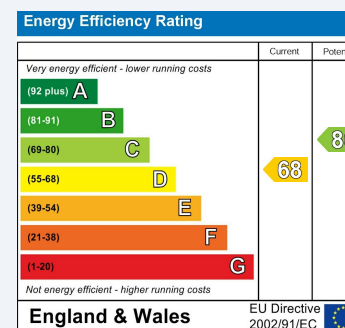
