Property Description

St George is a residential district in East Bristol about 2-3 miles from the city centre. Its a well established suburb with local shops, parks and good access of the rest of Bristol by road or bus. 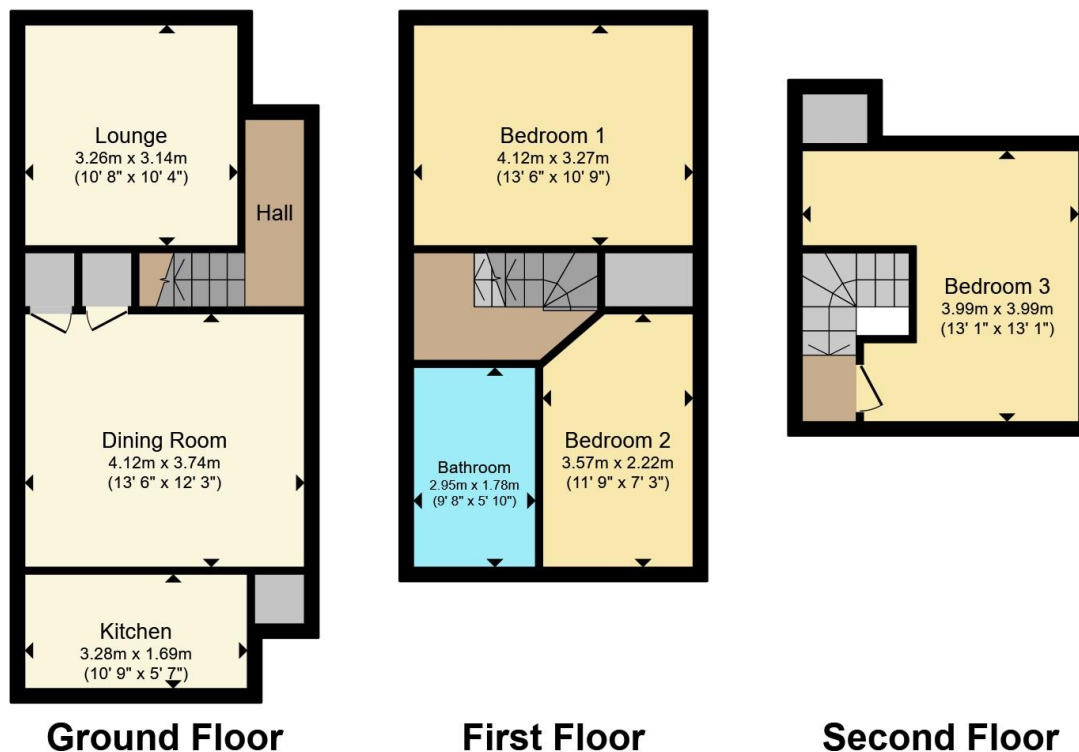
