The accommodation briefly comprises entrance hall, two bedrooms, cloakroom, utility room, to the first floor a lounge, kitchen/dining room, to the second floor a master suite with ensuite and dressing room, two further bedrooms, shower room, rear garden, garage and a driveway and carport.**

Comprising stainless steel single drainer sink unit with cupboard under, a range of eye level and base units providing work surfaces, plumbing for washing machine, space for tumble dryer, tiled splash backs, window and door to rear aspect, concealed wall mounted gas boiler serving domestic central heating and hot water systems, radiator.
