



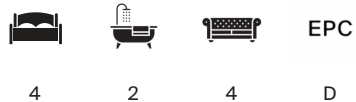

This residential building in Marlborough Road is arranged as two self-contained flats, which are being sold together as a single combined purchase.

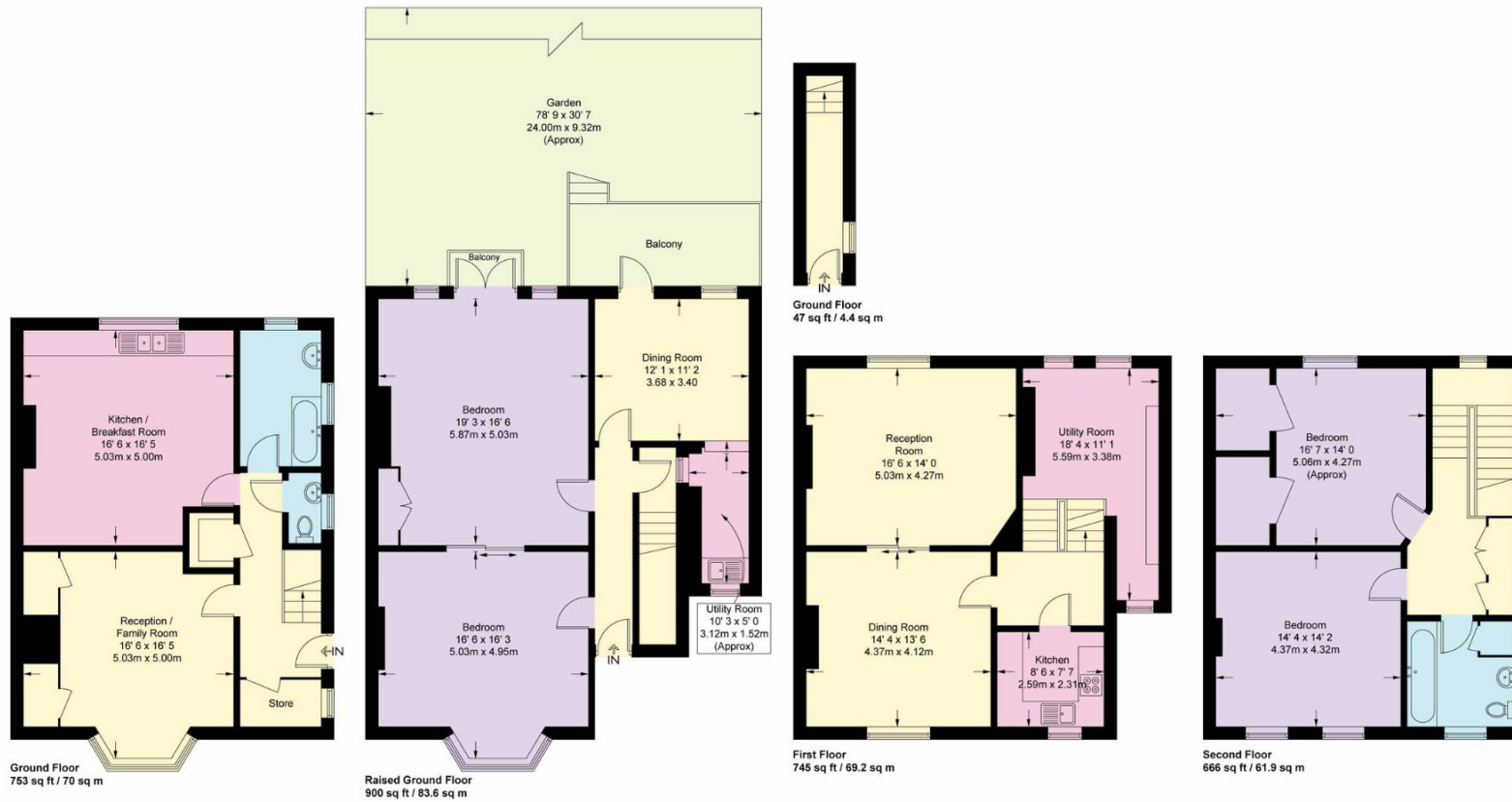
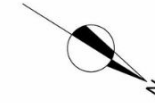
