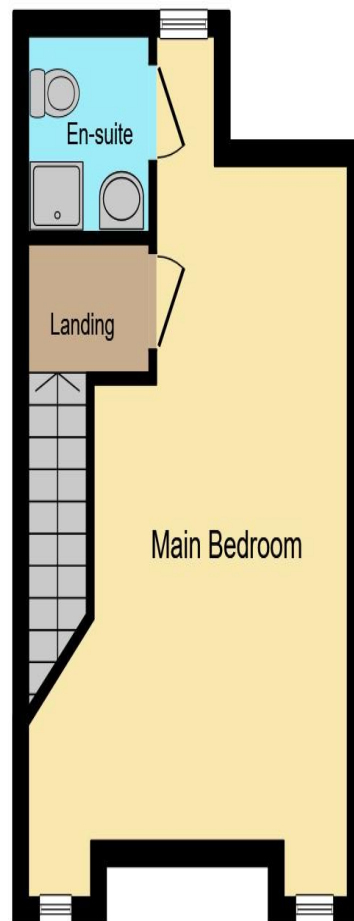




Ground Floor
