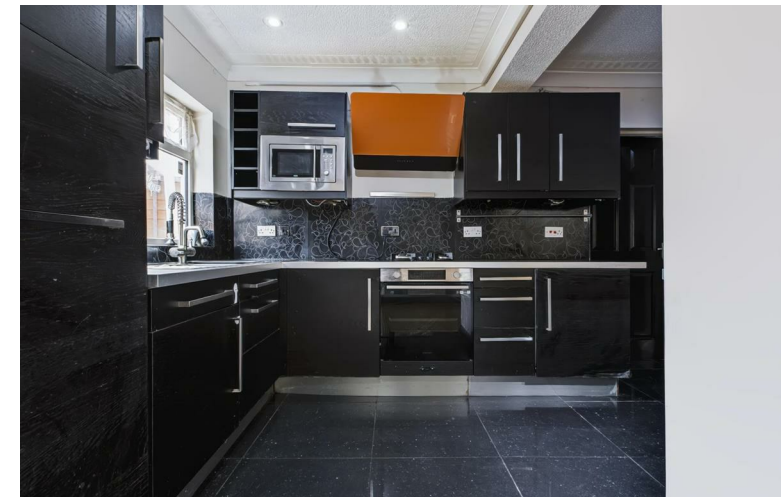
Description

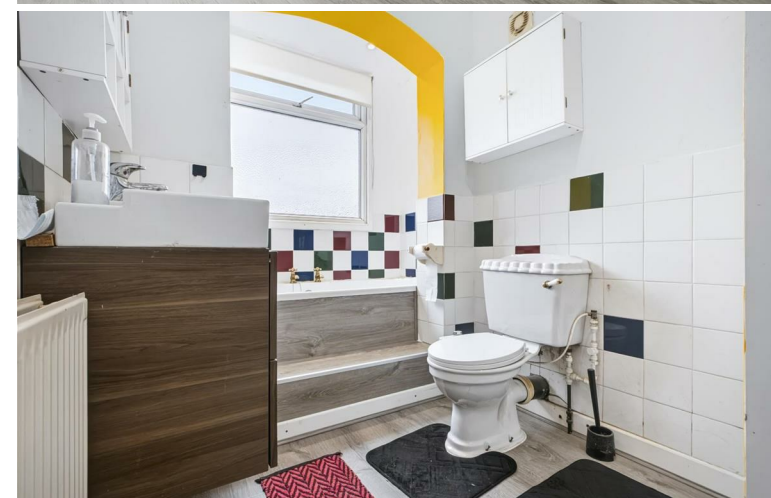

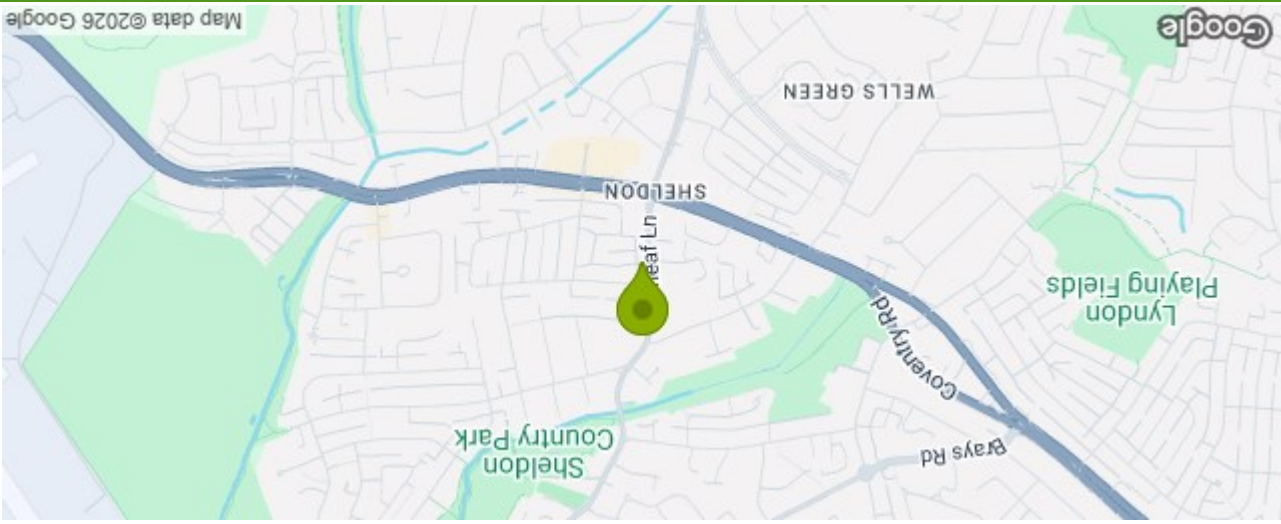
