A neatly kept and well presented, modern, one bedroom leasehold retirement apartment.

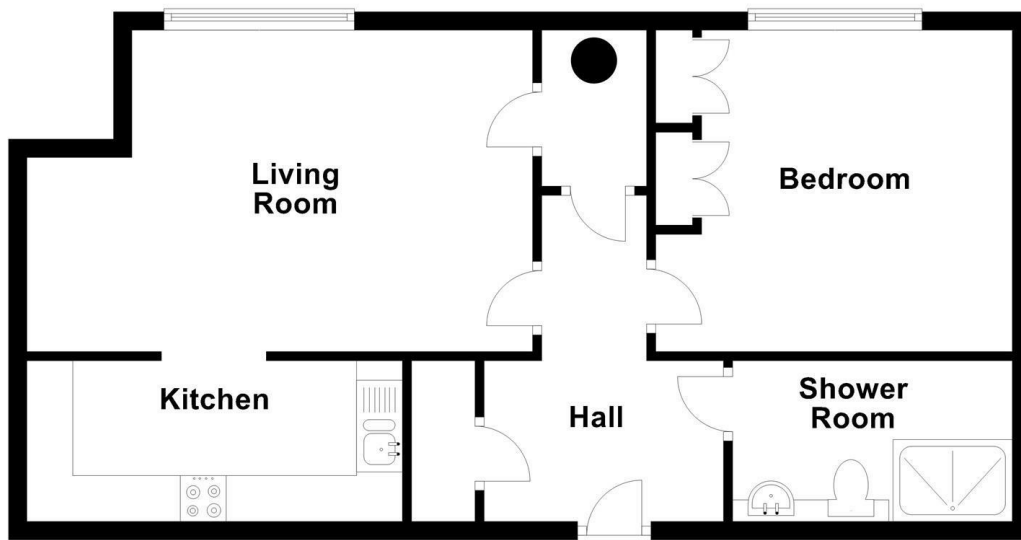

Turn right at the top, where Radbrook House will be found on the left hand side.

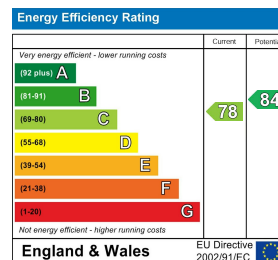
