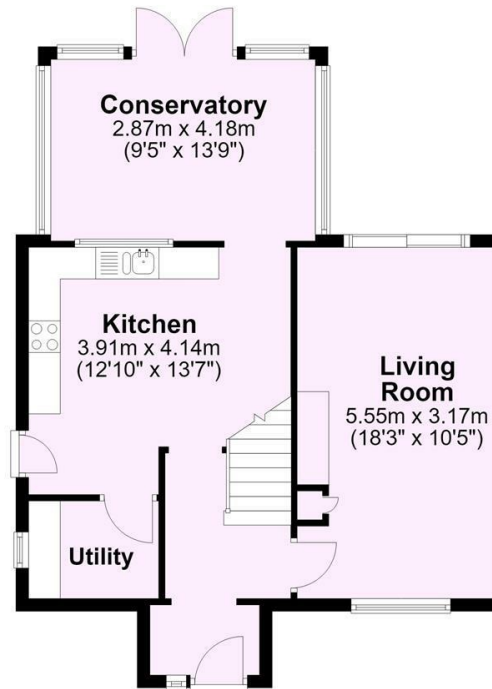

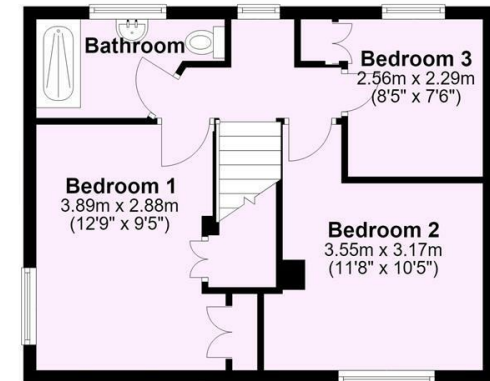
### Ground Floor

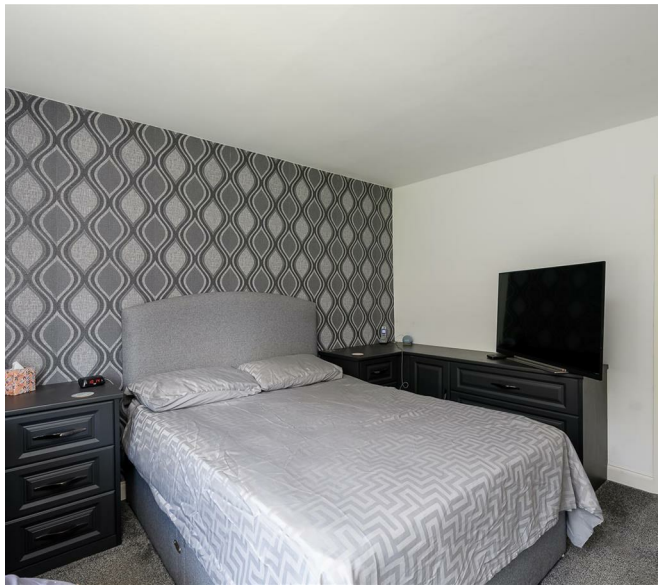

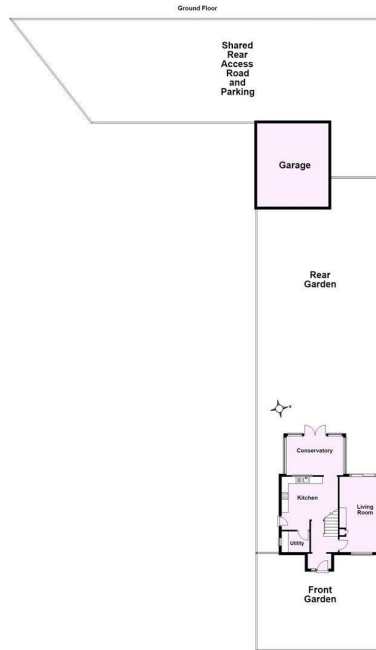
