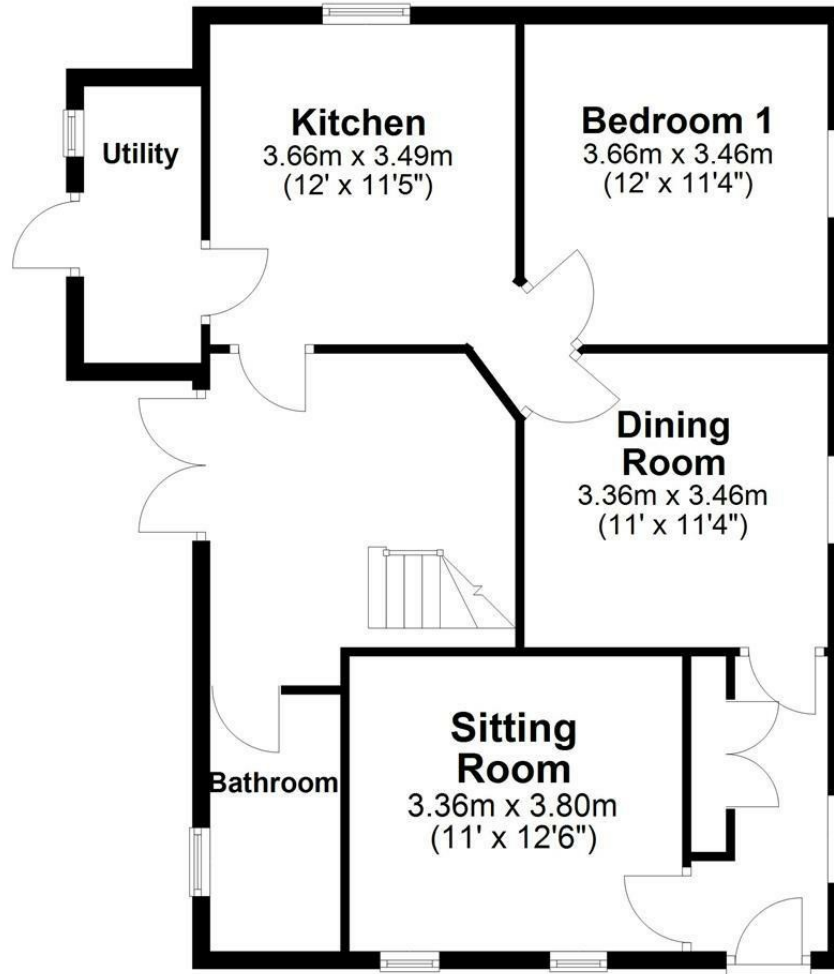

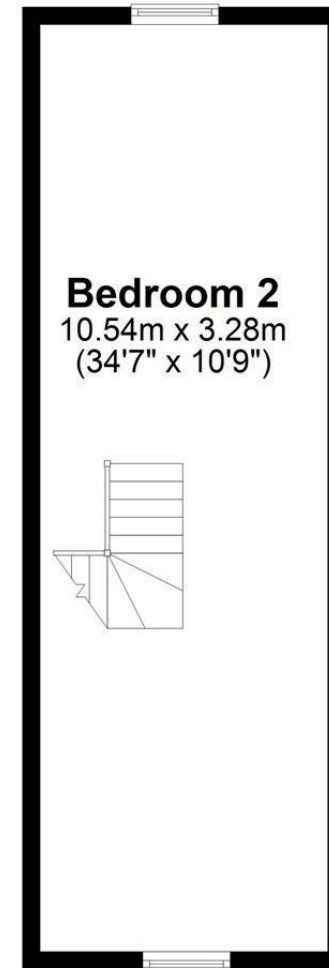
Ground Floor
