Property Description

This mixed-use property comprises a ground floor commercial unit with a two-bedroom maisonette arranged over the first and second floors. The ground floor provides flexible commercial accommodation suitable for a variety of business uses (subject to consent).

The maisonette offers well-planned living accommodation, with the first floor comprising a spacious lounge, a kitchen area, and a utility room. The second floor provides two bedrooms and a bathroom, offering comfortable and practical living space.

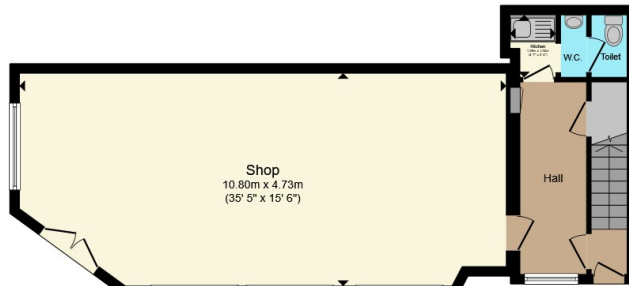

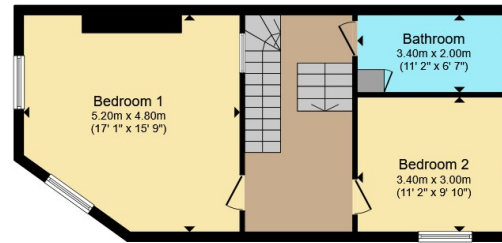




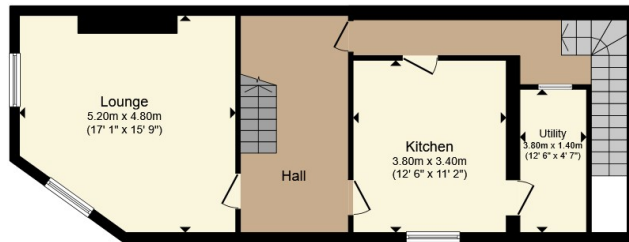




Ground Floor
