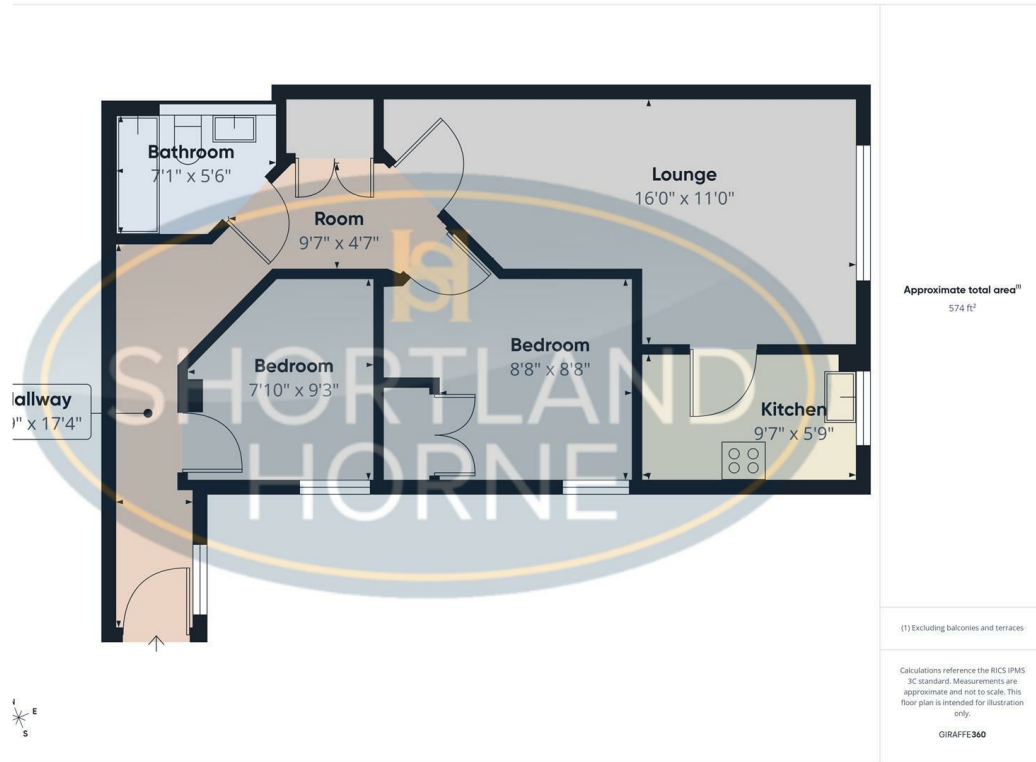


Floor Plan
