Description

The property comprises a generally level, rectangular fenced site of approximately 0.258 hectares (0.64 acres) comprising a mix of office, workshop and warehouse units with a combined floor area of approximately 1,255.90 sq m (13,519 sq ft) together with hardstanding providing external storage and vehicle parking.

Location

Wolverhampton is located 20 miles north west of Birmingham, 8 miles north of Dudley and 7 miles west of Walsall. The M6 motorway (Junction 10) is situated to the east of the city with the M54, to the north, heading eastwards from Junction 10A towards Telford. Wolverhampton mainline station is close by with regular trains to Birmingham in approximately 24 minutes and to London (Euston) with an average journey time of 1 hour 45 minutes.

The property is situated within a mixed use area on the west side of Showell Road, that runs between Guy Avenue and Bushbury Lane.
