Downstairs, the vendor has retained some of the original style features such as ceiling coving and the living room/dining room to the front of the property offers a versatile room that opens to the kitchen/breakfast area with doors to the enclosed and established rear garden. Upstairs, both bedrooms comfortable accommodate a double bed each with additional storage in each room. From the first floor landing runs a fixed staircase to the loft room. The room whilst structurally solid has had some alterations and would make an ideal project for some body looking to take it as is and finish to their own taste.

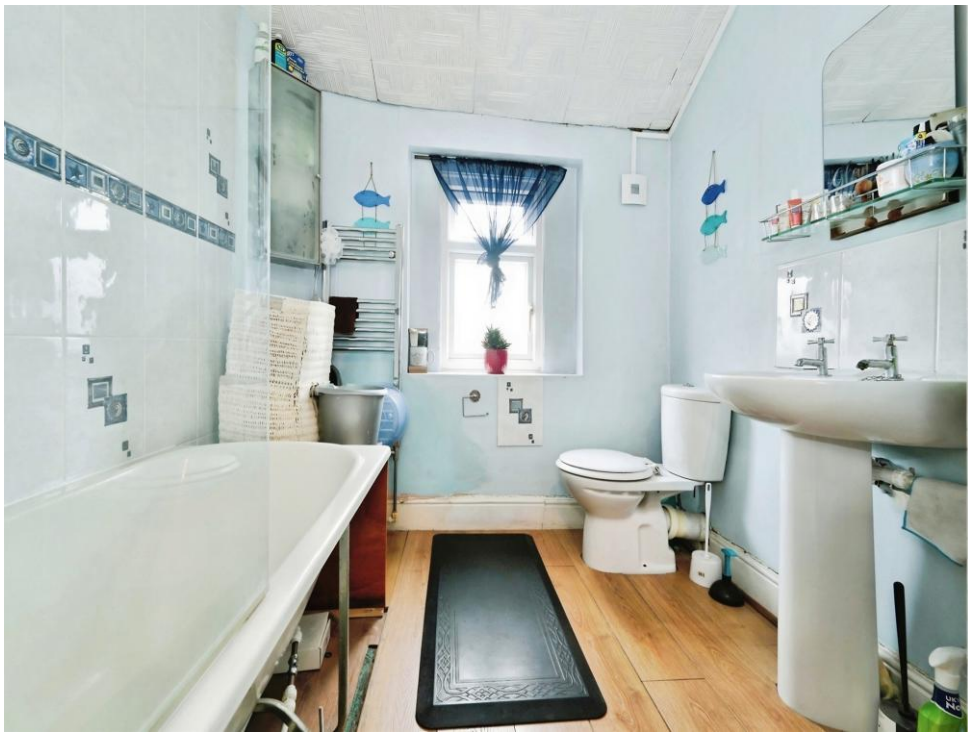
