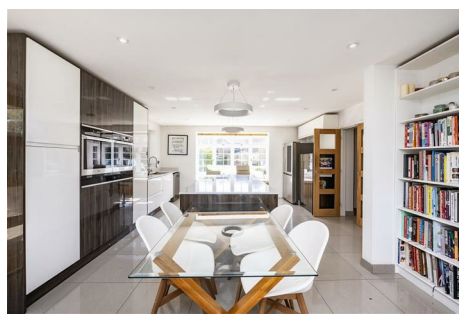




Middle Lodge Porters End Lane

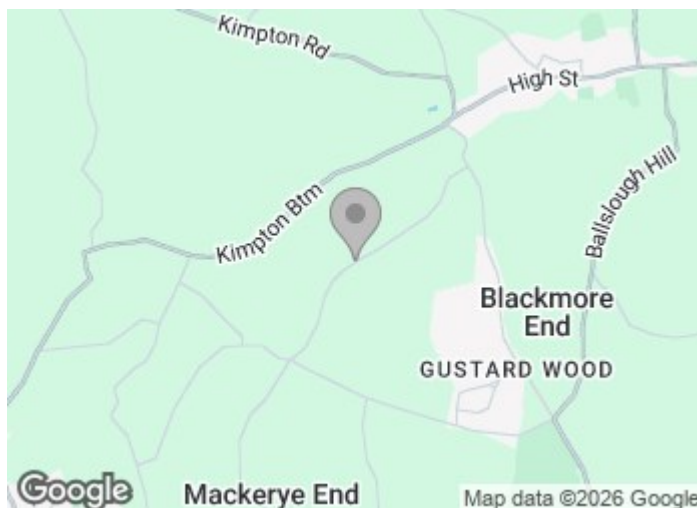

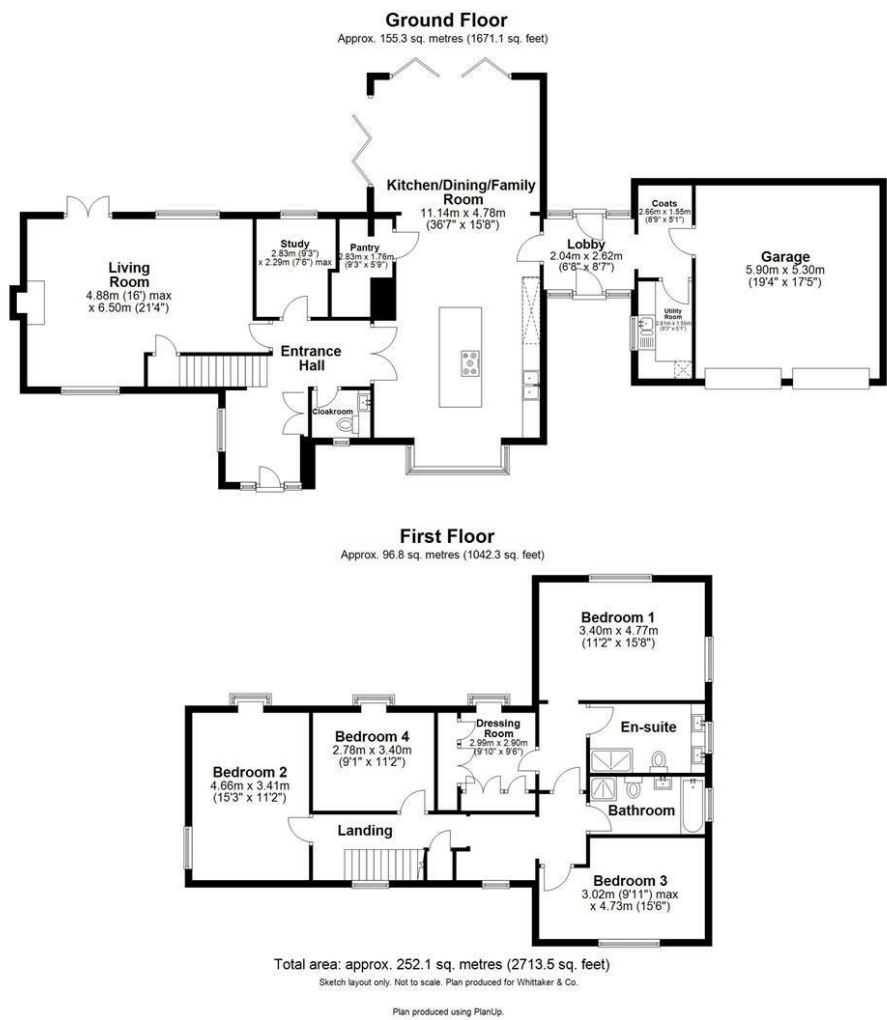
