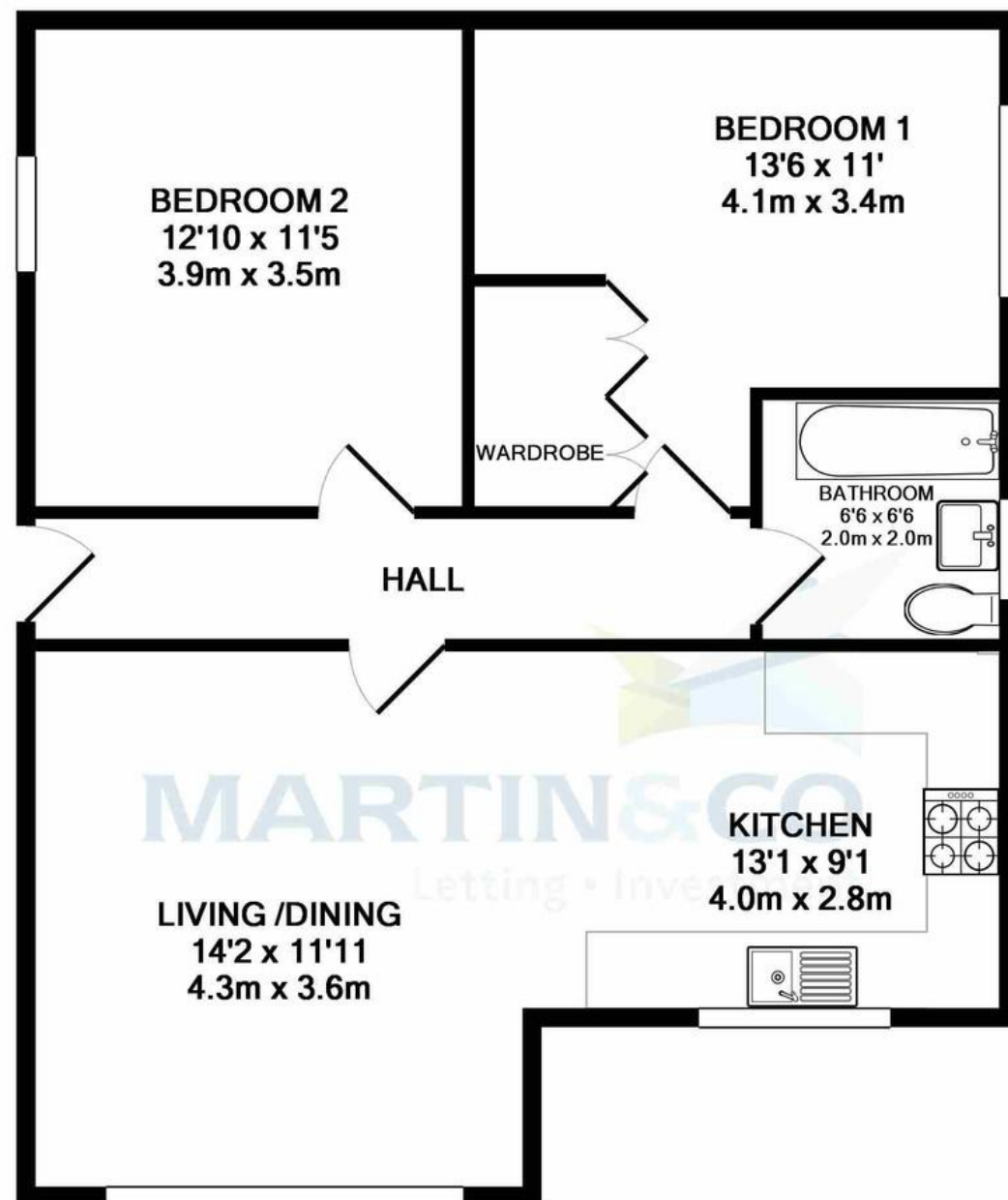

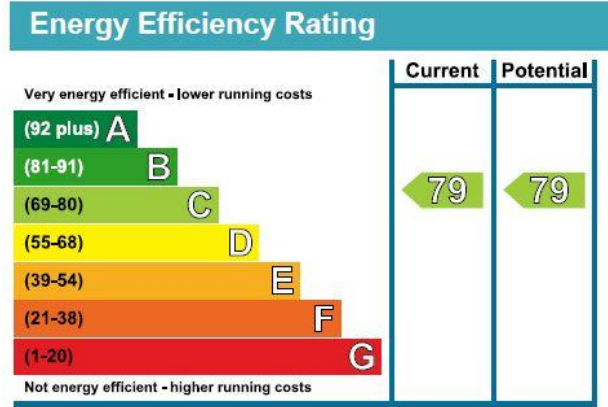
A modern two bedroom ground floor apartment, finished to an extremely high standard and located in the centre of Basingstoke.
