There is also a kitchen fitted with a range of floor and wall units. To the first floor there are three bedrooms, the master with a bay window, a bathroom and a separate w.c. 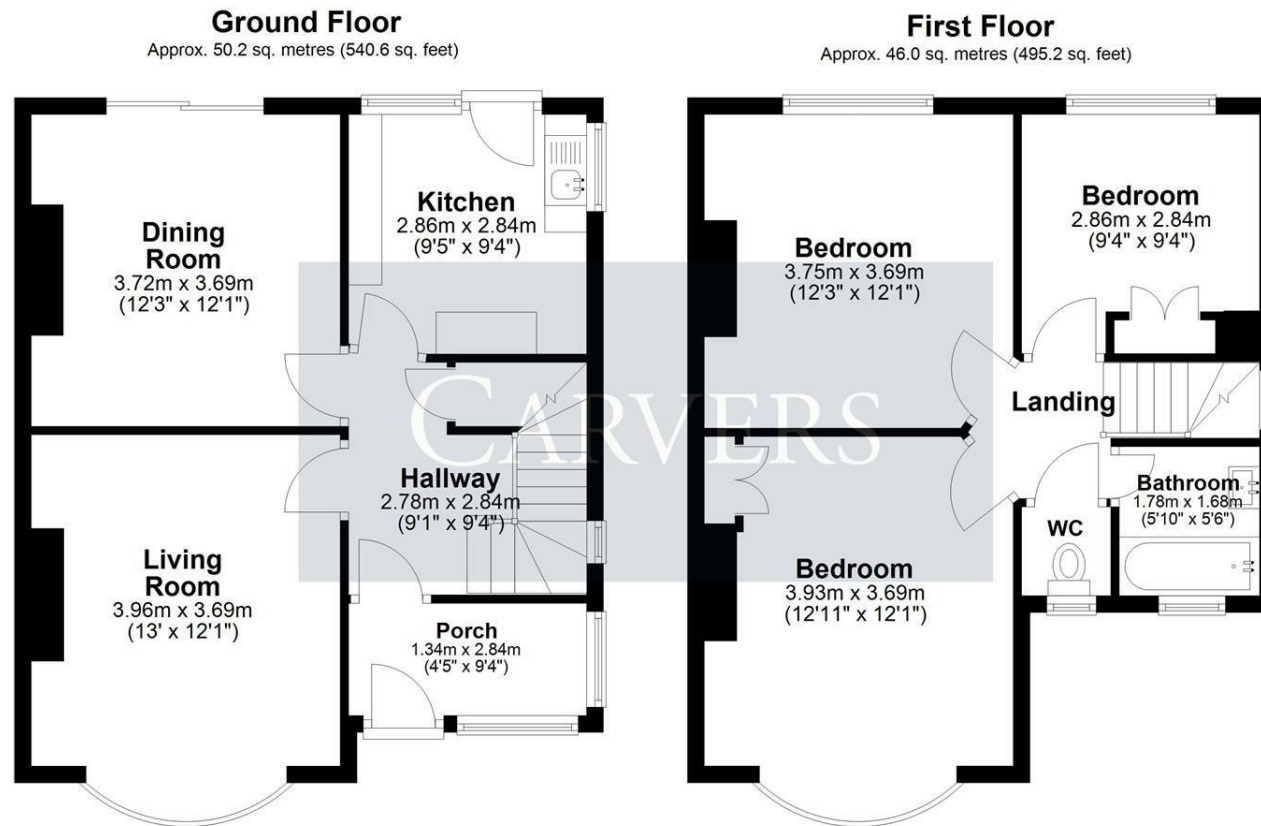
