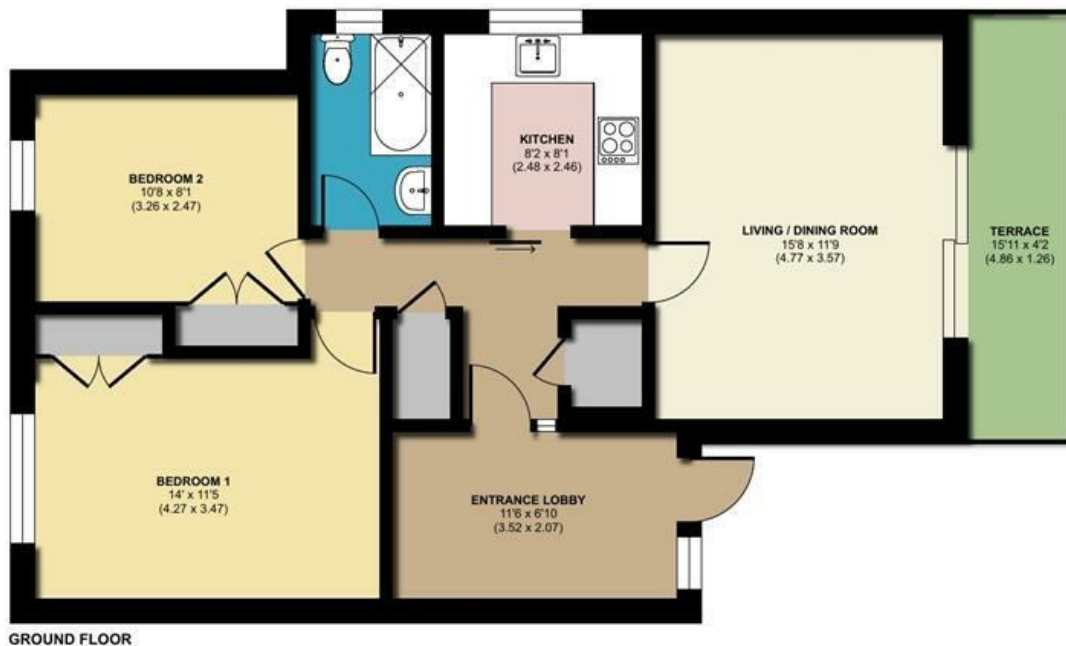




Nugee Court, Dukes Ride, Crowthorne
