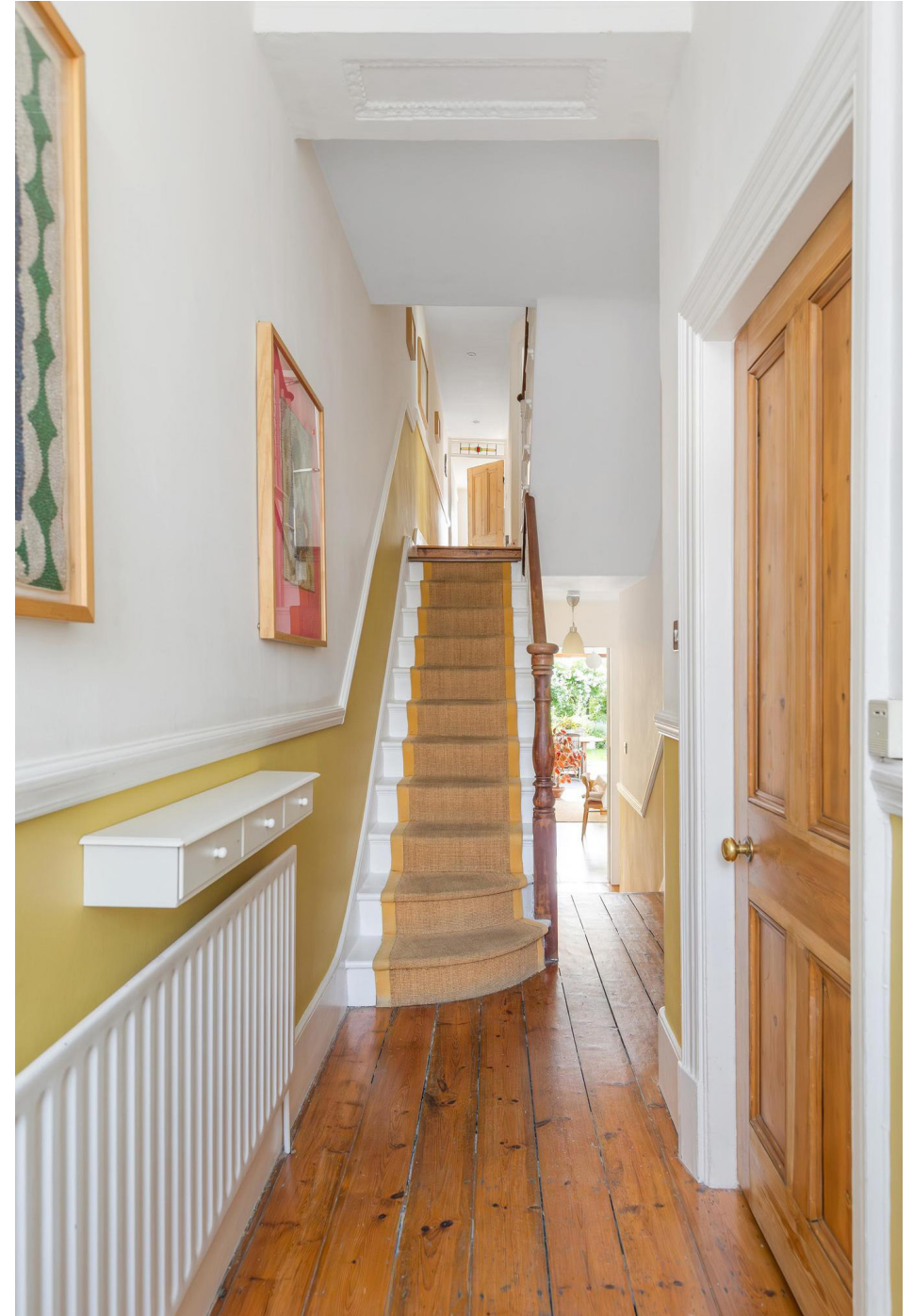

The house showcases lovely original wood flooring throughout as well as high ceilings and beautiful cornicing in the double reception space. Moving through to the stunning open-plan kitchen and dining area, bifold doors open to the well-maintained garden with a lovely terrace, quaint pond and a stepped patio to the rear. The ground floor is completed by a separate WC, cupboard and access to the cellar, perfect for storage. Upstairs on the first floor, the principal bedroom and two further bedrooms are serviced by a bathroom and shower room. The second floor comprises the fourth and fifth bedrooms as well as access to the sizeable crawl loft, again providing further storage or opportunity to extend subject to the required planning permissions.

There is a great selection of shops, restaurants, bars and cafés available on Lordship Lane. The wonderful green spaces of Peckham Rye Park and Dulwich Park are both in close proximity.
