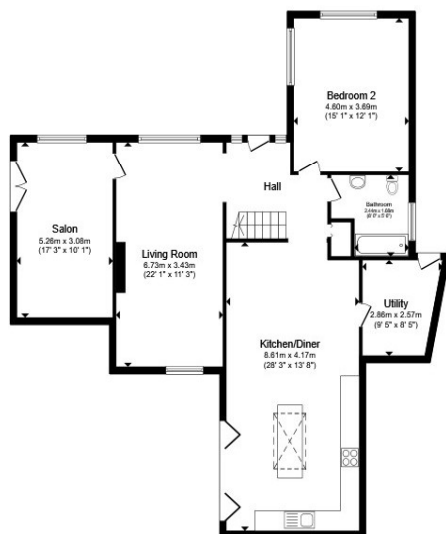

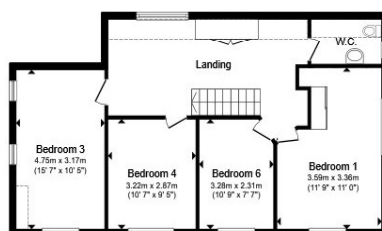

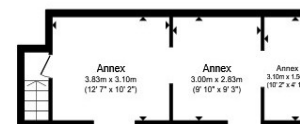
Ground Floor

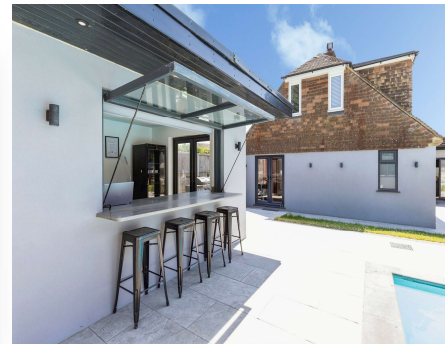
