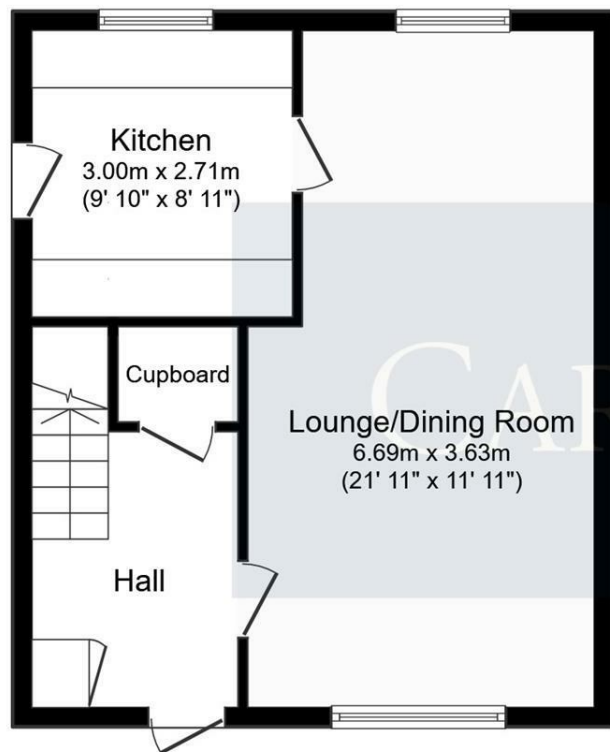
#### Buyers Identification Checks

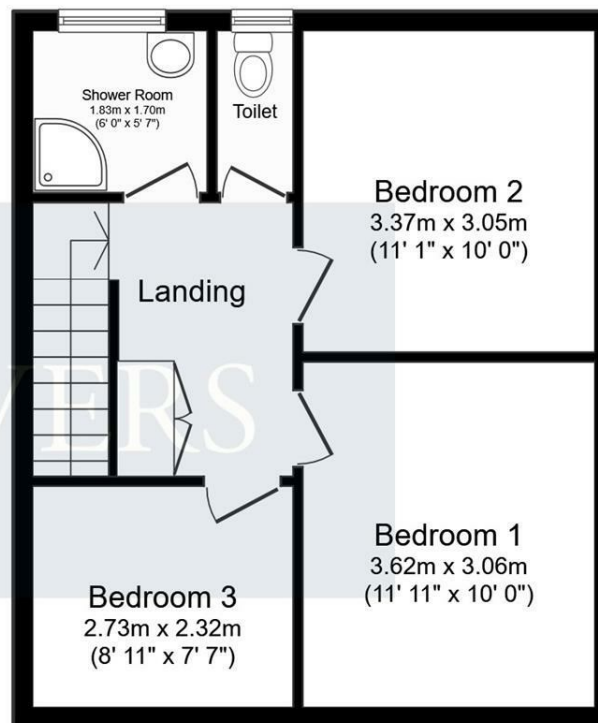
