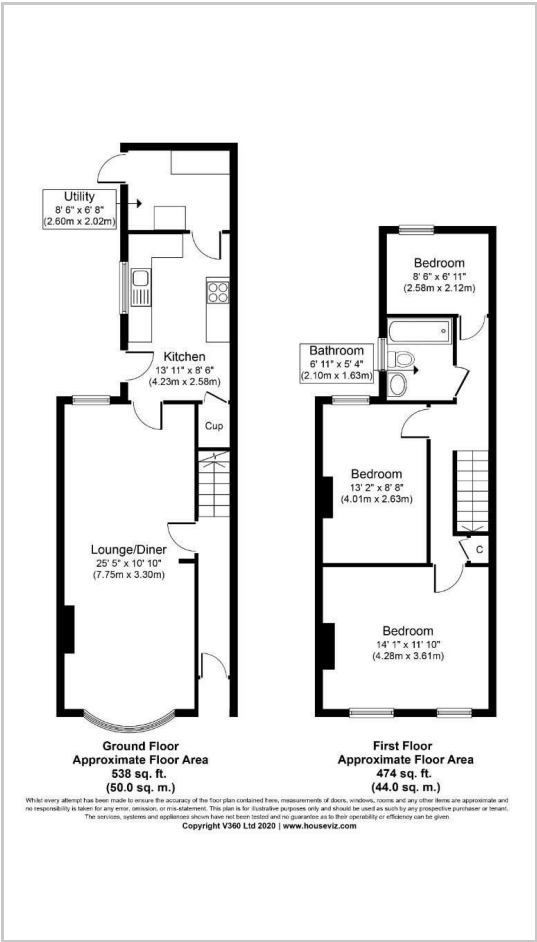
TENURE

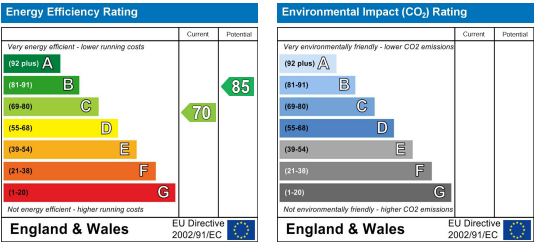
Area Map
