The location is particularly suited to buyers seeking a quieter residential setting while retaining convenient connections to the wider Leeds area.

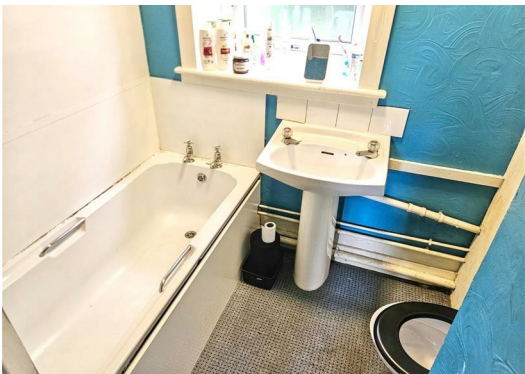
