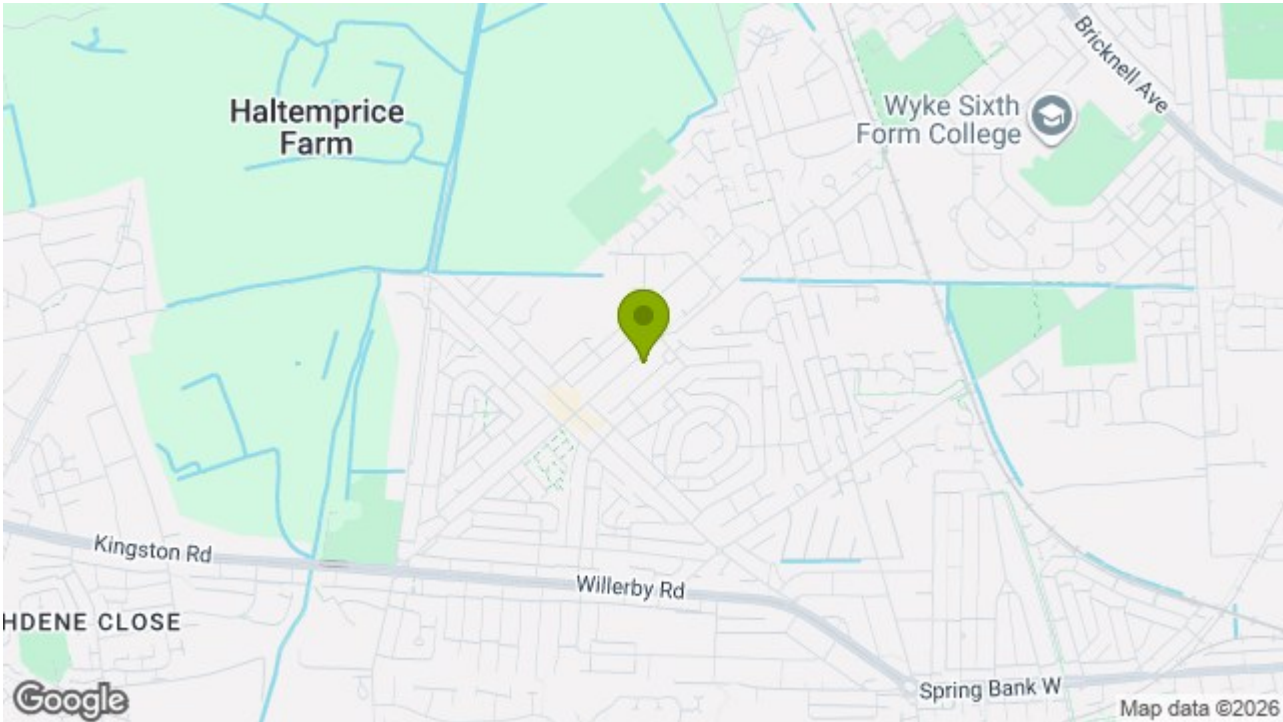

GROUND FLOOR;

ENTRANCE HALL

Providing access to the accommodation with stairs off.

LIVING ROOM

A well proportioned living space with laminate wood flooring, a bay window to the front elevation and access to the under-stairs cupboard.

LIVING DINING KITCHEN
