To the front, the garden has been converted to create driveway parking for two cars. Further benefits of this home include double glazing and gas central heating.

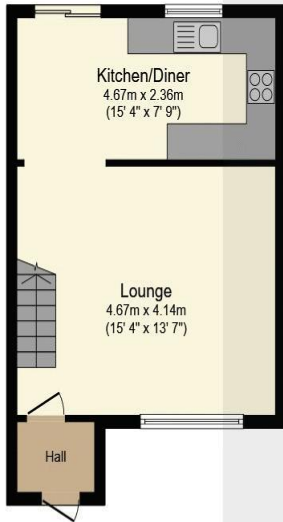

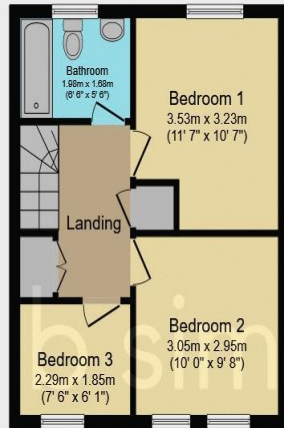

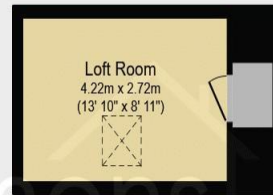
## Ground Floor

Floor area 42.4 sq.m. (457 sq.ft.)



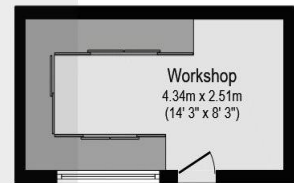
## First Floor
