The property is approached via a small front garden with pathway leading to the entrance. Stepping inside, the welcoming lounge instantly reflects the cottage's character, centred around an attractive gas fireplace creating a cosy focal point. The accommodation flows naturally through to the kitchen/dining room, fitted with a range of wooden units and providing ample space for a dining table, making it ideal for both everyday living and entertaining. The fridge and dish washer are included in the sale. From here, access leads directly out to the rear courtyard and garden.

The first floor hosts two bedrooms and the family bathroom. The principal bedroom is a generous forward-facing double room featuring a useful recessed area ideal for wardrobes, alongside a built-in cupboard. This room enjoys delightful harbour and sea views stretching across the rooftops of Brixham. The second bedroom is a single room, overlooking the back garden. Positioned to the rear, the bathroom is fitted with a bath and shower over, pedestal wash basin and W.C.

Stairs rise to the top floor where a spacious third bedroom is currently arranged as a twin room. Full of charm and character, the room features an ornate fireplace and enjoys stunning panoramic views across the harbour and out to sea, creating a truly special retreat within the home.

Externally, the rear outside space has been thoughtfully landscaped to maximise enjoyment of the elevated setting. A small courtyard leads via steps to a decked seating area finished with composite decking and contemporary glass and stainless-steel balustrades — an ideal space for relaxing, entertaining or simply soaking in the coastal surroundings.

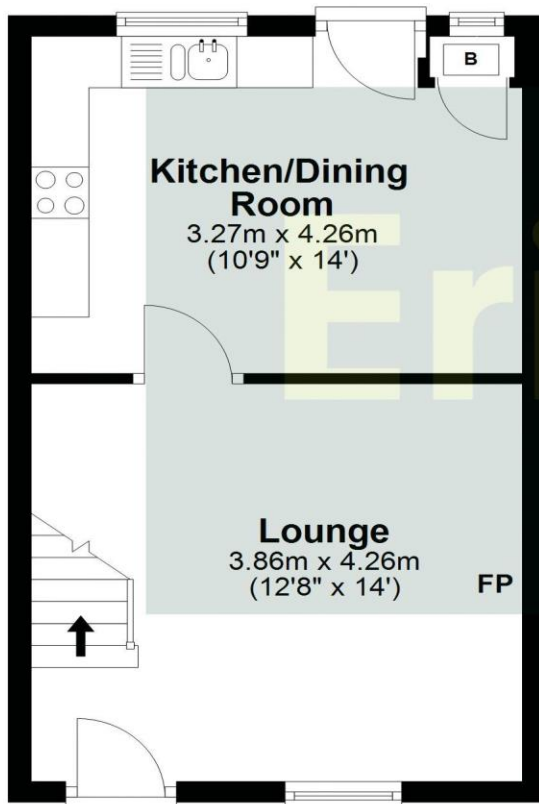

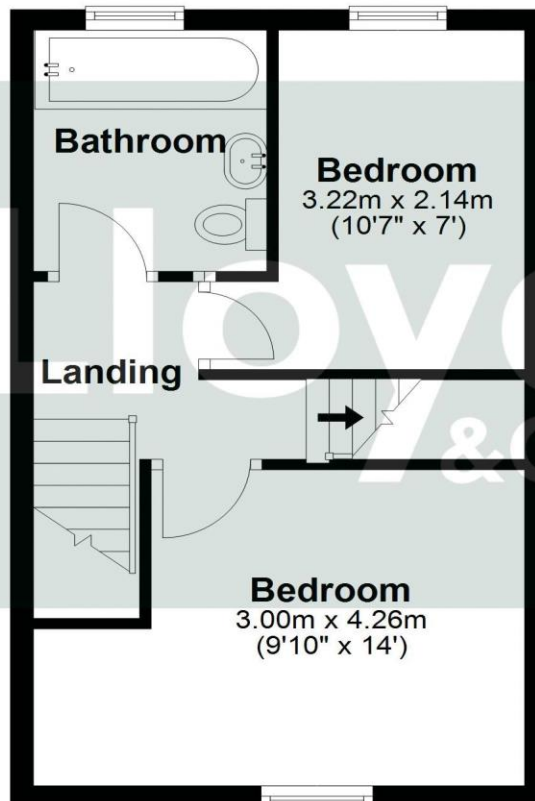
