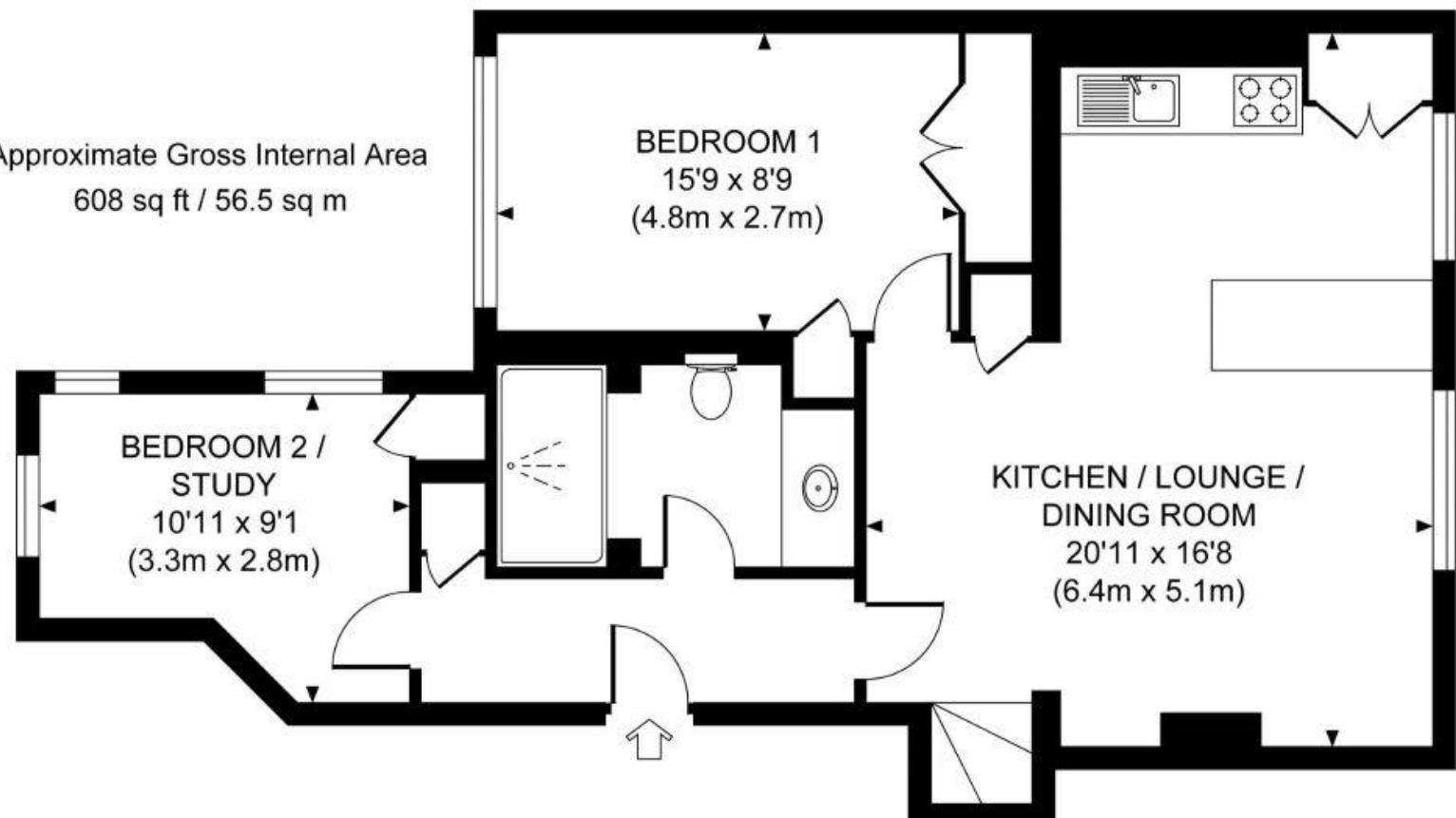
From our office in East Horsley turn left through the shops on the Ockham Road South for about one mile and Bishopsmead Parade will be found on your left hand side.
