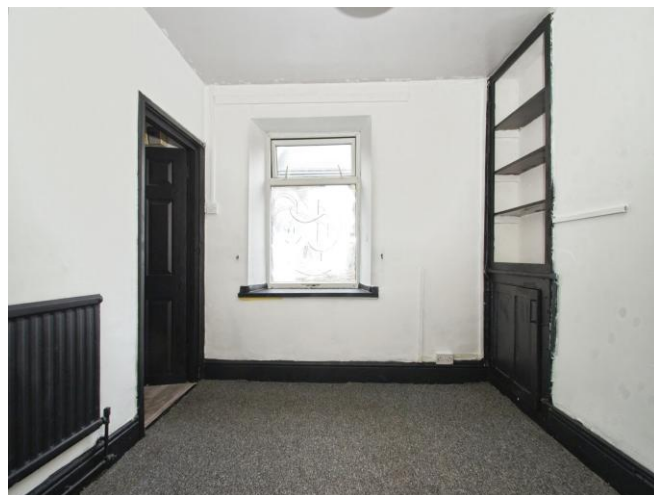

About the property

We are pleased to introduce this charming three-bedroom terraced home, ideally suited for first-time buyers or investors. Well-presented and ready to move into, the property requires minimal adjustments and offers a great blend of comfort, functionality, and location.

Internally, the accommodation comprises a welcoming hallway, a spacious lounge with feature fireplace, and a second reception room to the front - perfect for dining, a home office, or additional living space. The functional kitchen provides ample storage and worktop space, leading to a rear porch with direct garden access. A family bathroom with electric shower completes the ground floor layout.

To the first floor, there are three well-proportioned bedrooms, with the main bedroom to the front and two additional rooms to the rear. The home benefits from uPVC double glazing, gas central heating via a wall-mounted boiler, and the added advantage of solar panels for reduced electricity costs.

Externally, the property boasts an enclosed south-facing garden - a real suntrap - with a patio, tiered levels, storage sheds, and rear lane access.
