



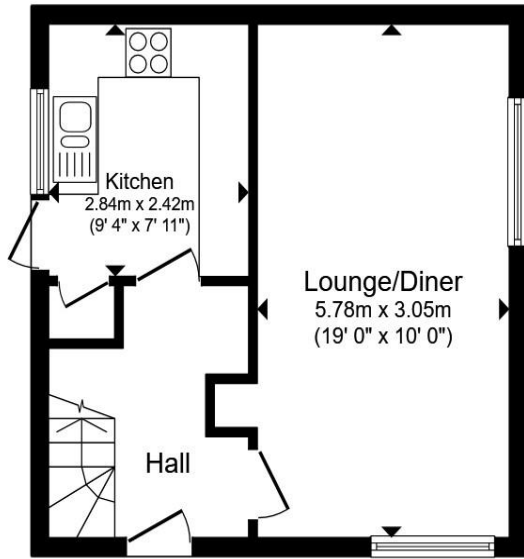

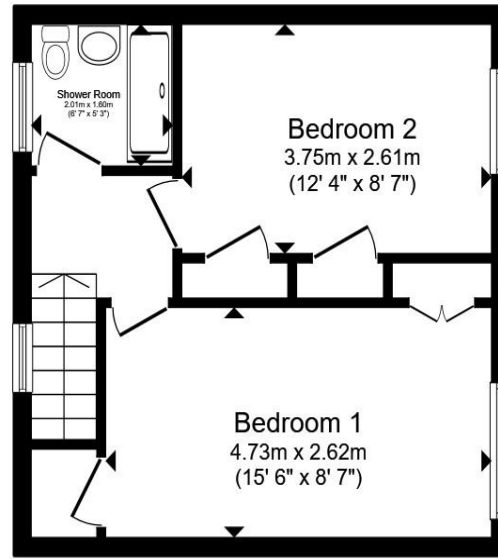

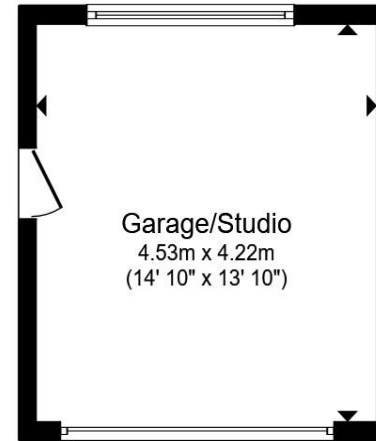




Ground Floor
