Double glazed window to front, central heated radiator.

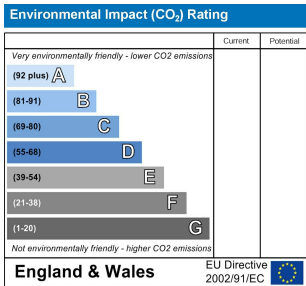
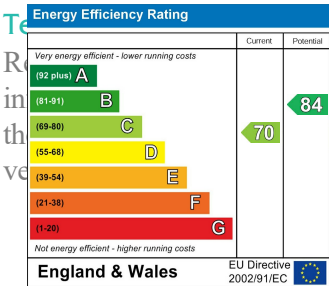


Bathroom

Money Laundering Regulations.
